That today i.e. 04.11.2023, I had gone to my tea garden to make wage payment. After receiving wages the workers were made an unlawful assembly and in a preplanned manner adamantly surrounded me and I was forced to make commitment for payment of bonus at that time itself and I was wrongfully confined at my office of my tea garden by the labourers from 12:30pm to 1:30pm approximately and my said office was ransacked by the labourers of our tea garden by throwing of my office table and other furnitures, filthy language was used and they threatened me with dire consequences including loss of life.

That the labourers threw chairs upon me with a view to cause physical hurt and injury but somehow I managed to save myself from their attacks and at one point one of the labourers threw another chair towards me which hit another person resulting one Rajesh Oraon sustained cut injury near his right eye. Even then the ferocity of the labourers continued and at one time one of the miscreants put a necklace of shoes on me causing loss of dignity and prestige was lowered down in the eyes of the public at large. Some photos regarding the above mentioned incident are annexed herewith.

That the labourers tried to assault the other official staffs of my garden and abused them with filthy language but due to resistance by locking of the doors they were unable to do so.

Thereafter after making further threats the labourers left the place and I was able to leave from the clutches of the miscreants. The entire incident happened under the leadership of Kafijul Haque, Soleman Md., Majaffar Ali and Shiraj Md. and others.

That the above four persons are creating disturbance and hackled the management to run the garden smoothly from beginning and they also create pressure upon the other labourers not to cooperate with the management of our tea garden.


That all the above mentioned incidents have caused me great mental anguish and agony and put me in fear of my life.

That due to such acts and actions there is an apprehension of serious breach of peace and loss of life cannot be ruled out.

I thus request you to take appropriate steps against the wrongdoers and bring them to justice.




