

Respected Sir,

With due respect I, SRI SWAPAN CHAKRABORTY, S/o. Late Dwijen Chakraborty, resident of Thiknikata, P.O. - Sushrutanagar, P.S. - Matigara, Dist. - Darjeeling, beg to inform you that I have purchased a shop room at measuring 165 Sq.Ft. by virtue of a sale deed being document no - 1417 for the year 2021 situated within Thiknikata Mouza, J.L. no - 74, Plot no - 269, recorded in Khatian no - 2133 from One Shyamal Biswas who was the absolute owner of the said shop room since the date of purchase to till date I am in possession of the aforesaid shop along with entire front area.

It is very unfortunate to mention here that some local people namely 1. Sri. Ankur Mandal, Son of Sri. Ashok Mandal Chandra, 2. Prashanta Bhakta @ Bartik Ch. Bhakta,, Son of Not Known, 3. Tapash Mandal, Son of Dilip Mandal, 4. Manas Mandal, Son of Dilip Mandal, 5. Biswajit Saha, S/O - Sri Manoranjan Saha, 6. Prabhat Das, S/O - Sri Ganesh Das, 7. Rahul Sah, S/O- Sri Laxmi Sah, all are resident of Thiknikata, P.O. Matigara, P.S. Matigara, Dist. Darjeeling (W.B.) all are illegally trying to make a Kali Puja Pandle in front of my shop room without my permission or without giving any intimation to me.

It is to be noted here that I have protested against to make Kali Puja Pandle in front of my aforesaid Shop Room but it is very unfortunate that even after my protest, all the above noted persons along with their anti-social friends are illegally trying to make Kali Puja Pandle there.

It is also to be note here that I have lodged a specific complain against the above named persons on 04/09/2023 and I also came to know that there are several cases (both Civil and Criminal) filed by Ratan Saha (owner of another shop room) against them vide Matigara P.S. Case no - 470/2023 Dated 15/06/2023, U/S- 447/427/323/384/506/34 IPC One Petition Case vide Petition case no - 41 / 2023, under Section 144 of Cr. P.C. and One Tittle Suit being no - 266 / 2023 and all the cases are pending and sub-judice and during the pendency of the above noted cases all the anti-socials are forcefully trying to harass me by making Kali Puja Pandle thereon without my permission and with a motive to illegally capture my shop room.

The Kali Puja Pandle premises and its eternity (where the above named persons forcefully are trying to make Pandle) is occupied by me and is in my possession but they all are still illegally and by using their muscle power are trying to make Kali Puja Pandle thereon even after my strong protest and they all are also threatening me that if I protest them for not to make Puja Pandle thereon then they will implicate my name in some false case.

It is therefore prayed that having no other alternative, I am requesting you to stop to make illegal Kali Puja Pandle in front of my aforesaid shop room and you are also requested to enquire into the matter neutrally and please, do take all necessary legal actions against their illegal activities for ends of justice.
