I, Shibnath Dey, Son of Gour Chandra Dey, Resident of Shaktigarh Road No. 1, P.O Siliguri Bazar, P.S. NJP, District: Jalpaiguri, do hereby lodging this F.I.R. in the following way:-

1. That I am an interior designer by profession having my firm under the name and style 'Dey Furniture Galary'. And one Abhijit Saha S/O of not known, resident of Babupara near Krishna Kunja Bhavan, beside Kidzee School, P.S Siliguri engaged me to design his chamber at his residence and the cost of the entire work is Rs.3,30,000/- and on and from the first week of August 2023 I have started designing his chamber. It is added further that the said Abhijit Saha made payment of Rs.2,90,000/- through account transaction and today i.e. on 06/11/2023 the entire work of interior of his chamber been completed and after completion of the said work when I ask him to make the payment of the balance amount at that moment the said Abhijit Saha started abusing me with filthy language and hearing his voice his son came down from his residence and suddenly started assaulting me physically with his father and when I raised objection against their illegal activities and also ask the reason of their behavior the said Abhijit Saha threatened me by saying that he is an advocate by profession and also a retired police personnel and he will ruin my entire life framing me in an false and fabricated case. Moreover his son brutally assaulted me with a heavy object resulting which the middle finger of my left hand has been fractured and also they tried to

strangulate me with the gold chain I was wearing and when I was busy to settle in my pain at that time the said Abhijit Saha and his Son snatched away my Gold Chain measuring about 14gm along with my diamond earring and the entire incident is recorded in the CCTV installed at the Chamber of Abhijit Saha and at the time of this incident my workers were present at the chamber of the said Abhijit Saha and hearing my hue and cry they came and witnessed the entire incident and with the intervention of my worker I somehow managed to escape and after that my brother took me to the Siliguri Sadar Hospital where I have been treated.

So, I am praying before you that necessary action may kindly be taken against the illegal act and activities of the said Abhijit Saha and his son.
