Subject: Criminal Complaint against Akshay More, S/o Late Rakesh More, Prop. of Laxmi Distributors, situated at Bidhan Market, Ward No. 11, P.S. Panitanki Town Out Post, P.O. Siliguri for commission of cognizable offence under various sections of Indian Penal Code, 1860.

Madam/Sir,

I, Sri. Samir Ghosh, S/o Late Pulin Chandra Ghosh, aged about 51 years, R/o Ward No. 7, Ghoshpara Siliguri also residing at M/s Subho Sandesh, Bidhan Market, Ward No. 11, within the jurisdiction of your police station and I am fully aware of the complete facts & circumstances of the present matter and filing the present criminal complaint in my personal capacity and in lieu of the same, I would like to bring the following to your kind information: That, the instant complaint is against, one Akshay More, S/o Late Rajesh More, Prop. of Laxmi Distributors, situated at Bidhan Market, Ward No. 11, P.S. Panitanki Town Out Post, P.O. Siliguri and unknown persons. The said Proprietorship firm is run and managed by the above-mentioned Akshay More and engages in business of different natures. It is also significant to state that I am the actual owner of the aforesaid land upon which the proprietorship concern is situated as per records of the Government of West Bengal. I also have the 42/331/458, issued by the Siliguri Municipal Corporation and the same is issued on father's name. That today i.e. 07/11/2023, at around 08:15am, when I visited my property for general course of inspection as authorized by law, the above-named Akshay More, without any provocation, started to filthy hurl abuses on me. When I tried to stop the quarrel, he suddenly started to physically hurt me by inflicting me physical harm for no reason. While he continued to physically abuse me and inflict harm on my body for fulfillment of his wrongful gain, he persuaded few other unknown miscreants to involve in the fist and blow situation that I was already under. Few musclemen, came along with dangerous weapons and the aforementioned Akshay More threatened me of dire consequences if I were to be ever be seen in and around my property. The medical slip, issued by the Siliguri District Hospital is attached herewith for your perusal. That, upon involvement of few more people in the Bidhan Market area, the said fight could be stopped, however, even towards the end of the dispute, he and few other men kept criminally intimidating me to grave consequences. That I have history of fractured leg due to an accident and I still suffer pain due to the said incident, the criminal assault on my body has also led to damage and deteriorate the said pain and I am extremely under fear and depression. That, since the very beginning of the dispute, and until very

recently, Akshay More has tried to criminally damage my repute and cause me grave injuries and also threatened me of dire consequences in connivance with few unknown musclemen and miscreants carrying dangerous weapons. That, the accused, being well versed of the fact that his actions are unlawful and punishable under prevailing criminal laws, having utter disregard to the law of the land has continued his criminal behavior causing disturbance in peace and order of on the aforesaid property. That, the accused has voluntarily, with an intention to cause wrongful gain has constantly and perpetually threatened me and my family members of dire consequences, including threat to cause grievous hurt or death in order to occupy my property by illegal means. That, the above named accused by criminally intimidating me that he shall grievously harm me and/or my family members and implicate me in a false case of criminal breach of trust has thus committed the offence of "Criminal intimidation". That the accused has also by malafide intention and criminal mindset in collaboration with few miscreants has injured me badly, by causing and inflicting physical harm on my body. It is pertinent to mention that the accused is a seasoned criminal, and has continued to cause wrongful loss to me in sheer fulfillment of his ulterior motives and in ultimate violation of the law of the land. That, as you know, I am an age-old resident of this area and have a good reputation in the area. The accused in fulfillment of his illegal motives has from time to time publicly humiliated and defamed me. It may be noted that such imputations made by him towards me has caused me severe damage to my integrity in the society. The accused publicly to humiliate and insult me and disrespect and insult through his oral imputations.

Therefore, I request you to enquire into the matter and book the aforesaid culprit namely, Akshay More, S/o Late Rajesh More, under appropriate provisions of law.
