Dear Sir/Madam,

I am writing to formally file a complaint and request an immediate investigation into an incident that SPC
occurred on 07/11/23 at my shop premises, located at Bidhan Market. I hold a lease for this shop for
over 30 years, and after my father's passing, I have been managing it for my personal use.

On the morning of 07/11/23, I took necessary action to address a safety hazard concerning the exterior
board of my shop. The board had sustained damage, and it was hanging precariously from the wall,
posing a severe risk to anyone passing by. To ensure the safety of the public, I hired a few workers to
remove and replace the damaged board.

During this process, a situation escalated when one of the owners of the building, whose actions were
recorded by a nearby CCTV camera, confronted me. He not only verbally abused me but also resorted to
physical violence, assaulting me in the process. Fearing for my safety and well-being, I had no choice but
to defend myself and obstruct his aggression.

I am deeply concerned about the safety and security of my shop, as well as the welfare of the public in
the vicinity. I kindly request that the police department conducts a thorough investigation into this
matter. The recorded evidence from the CCTV camera should provide clear proof of the incident and the
unwarranted assault I suffered.

I implore you to take prompt and appropriate action to ensure that justice is served and that I can
continue to manage my shop without any further hindrance. I am also concerned about my personal
safety and that of others in the area, given the behavior of the building owner.

I am willing to cooperate fully with the investigation and provide any necessary information or evidence
to facilitate the process. Please keep me informed about the progress of the case and any legal actions
taken against the individual responsible for the assault.

I hope for a swift resolution to this matter and trust that the law enforcement authorities will uphold
justice and protect the rights of citizens. Your assistance and intervention are greatly appreciated.
