Sir,

Being sheerly compelled I prefer to lodge this complaint against one Shibnath Dey of Shaktigarh Road No.1, PS.NJP Dist. Jalpaiguri (details below) whom I entrusted for whole interior of my Law chamber at a portion of my residence and paid him ₹ 2,90,000 out of the assigned estimate & for execution the plan of work Rs.2,99,000/ as well as for agreed completion of all assigned interior works. But said alleged Designer never kept his commitment and all along since 31st August'23 remained negligent in his performance and his fitting and fixtures are all of below quality away from his initial allurements. I myself had to arrange many equipments amid the process with due arrangement that we both will decide the expenses incurred by me and settle up the finality.

But yesterday (i.e.on 06.11.23) evening before any such sitting alleged interior Shri Dey came to my home all on a sudden and forcibly started insisting me to pay up the dues as per his whims which I did not do and forthwith he turned to horrible fury and pounced upon me and assaulted my son who came to rescue me and the said person also snatched his gold ring during the pandemonium. On the act of alleged Person my son sustained bleeding injuries and under treatment (Annexed Treatment Sheet)

The act and action of this person is of course cheating and breach of trust beside assault and robbery connected therewith which need to be addressed as per and I hope due action from your end .
