

Sub: Submission of Complaint for attempting to commit theft by break open the State Bank of India's ATM terminal (ATM ID: T1NF004789165) situated at Vill Shanti Pur, Opp. Power House, Post Kadam Tala, Darjeeling (Dist), Shib Mandir-734011.

Respected Sir/Madam,

We, M/s Financial Software and Systems Private Limited, a company incorporated under the Companies Act, 1956, and having its registered office at No, 42, 3<sup>rd</sup> Main Road, Ground Floor, Saradha Apartment, Gandhi Nagar, Adyar, Chennai-600020, represented by Mr. Debabrata Bramha and inform as herein under:

Our Company is a leading global payment systems company, offering business value in the areas of electronic payment, financial transactions, processing solutions and services. We have earned the status of being a payment systems leader through a combination of a well-established portfolio of technology solutions and state-of-the-art infrastructure and have garnered over 30 years of experience in the payment's domain. As part of our core business, we undertake end-to-end deployment of ATMs and ACRs and Managed Services pursuant to which we holistically manage the ATM activities ranging from site selection, asset deployment to managing the day-to-day ATM operations post set up of several nationalized and private sector banks all over the country.

- Thus, we have entered into various agreements with various nationalized and private banks
  to install and manage their ATMs across the country through various
  subcontractors/vendors.
- 3. In the regular course of business, we have entered into an agreement with State Bank of India ("Bank") for managing their ATMs including cash management services at various places including Siliguri. As per the terms and conditions of the Agreement executed between FSS and the Bank, FSS will be liable to the Bank in case of any cash shortage in the ATM and any damage to the ATM as FSS is providing ATM managed services to the Bank.
- 4. On 07.11.2023 at 2.30 AM (approx) unknown person(s) entered into the State Bank of India's ATM having ATM ID: T1NF004789165, situated at Vill Shanti Pur, Opp. Power House, Post Kadam Tala, Darjeeling (Dist), Shib Mandir-734011, with a pre-planned intention, to steal the cash in the ATM by breaking open the ATM, using a gas cutter. As a consequence, the ATM has been fully damaged and cash laden in the ATM amounting to Rs.1,67,300/-(Rupees One Lakh Sixty Seven Thousand Three Hundred only) has been burnt. There were total cash amounting Rs.9,18,200/- (Rupees Nine Lakhs Eighteen Thousand and Two Hundred only) comprising Rs. 200 (1246) & Rs 500 (1338) notes in the ATM when the accused tried to break open the ATM by using gas cutter. Rs. 1,67,300/- comprising Rs 500 notes counting to 200 have been burnt because of this theft attempt and remaining Rs.7,50,900/- is found in order. The accused has clearly attempted to take cash from the ATM by breaking the ATM with a dishonest intention to steal cash in the ATM.
- 5. Therefore, we request you to take urgent action against the accused who damaged the ATM and tried to take cash from the ATM unlawfully with pre planned intention.
