Sir,

With due respect, I, undersigned beg to state that on 11.07.2017 my marriage was solemnized with Sri Pradip Roy, S/o. Sri Harkumar Roy of Garteshwari, Satkura, P.O. Berubari, Distt. Jalpaiguri as per Hindu rites & customs at the house of my father Sri Upen Singha at Vivekananda Pally, Durga Mandir, P.O. Kadamtala, P.S. Matigara, Distt. Darjeeling and after marriage I came to my in-laws house at afore-mentioned address and out of this wedlock, a son namely Mayank Singha Roy was born on 29.07.2018.

Sir, after expiry of some days, I came to know that my husband is a habitual drunkard and he has also an illicit relationship with his sister-in-law namely Smt. Tumpa Roy, who is the wife of his cousin brother Sri Bhattu Roy of Garteshwari, Satkura, P.O. Berubari, Distt. Jalpaiguri. Sir, he always used to come in drunken condition and used to demand money from me although many times I paid him money from getting my father but his demand is increasing day by day but whenever I deny to fulfill his demand he used to beat me with fist & blow on several occasions he has beaten me brutally even he use to say that my parents are old aged and also I do not have any brother so no can save me from his claws and after the death of my parents he will become the owner of the property of my parents. Sir, he and his parents repeatedly demanding money from me for constructing their house but on my denial to pay the money they use to torture me both mentally and physically.

Sir, I submit here that on November 2020, at night he came in drunken condition and again started to demand me money but when I denied his parents instigated him to beat me so he brutally beaten me up in result I got injured so I called up my father so my father along with my family members came to my in-laws house at mid-night and we went to the concerned police station but after the intervention of local Panchayat/Pradhan and as my also also repented and said in future he would not repeat such incidents and just to save my marriage I did not file any case against him but after some days he was the same as earlier. He always treat me very badly and dis-respectfully and even in front of me, he makes romantic calls with Smt. Tumpa Roy over phone just to give me pain and hurt.
