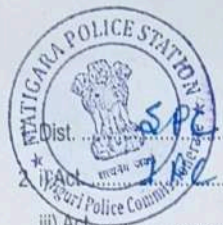


Sir,

In producing herewith 02 (Two) arrested accused persons namely (i) Nazrul Islam (24) s/o Hazarat Ali of vill- Baniapara, PO Garehari, PS Barpeta, Dist. Barpeta, Assam and (ii) Makabul Ali (30) s/o Lt. Abdul Rahaman of vill- Baniapara, PO Garehari, PS Barpeta, Dist. Barpeta, Assam arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One Black Color Mahindra Brand, XUV 300 four wheeler vehicle bearing Registration No. AS 01FA 3467 along with its one key.
- (2) One piece of iron made steel bolt cutter measuring approx 46 cm including blue handle measuring approx 22 cm and black color handle grip measuring approx 12 cm inscribed "TAPARIA" (brand name).
- (3) Indian Currency Rupees Five Hundred (Rs 500/-) in denomination of 1,624 pieces. [ Total Rs 500 X 1624 = Rs 8,12,000/- (Rupees Eight Lakhs Twelve Thousand Only) ]
- (4) Indian Currency Rupees One Hundred (RS 100) in denomination of 11 Pieces. [Total 100X 11= 1100 (Eleven Hundred Rupees Only)].
- (5) Indian Currency Rupees Two Hundred (RS 200) in denomination of 01 Pieces. [Total 200X 01= 200 (Two Hundred Rupees Only)].  
[Total Rupees is Rs 8,12,000 + Rs 1100+ Rs 200 = Rs 8,13,300/- (Rupees Eight Lakhs Thirteen Thousand and Three Hundred Only)]
- (6) One Black Color Backpack with tick mark on bag having three compartments in it.
- (7) One VIVO Brand Mobile Phone bearing IMEI ; 862431067934475 and IMEI 2: 862431067934467 containing SIM No. 7896254941.
- (8) One OPPO Brand Mobile Phone bearing IMEI 1 ; 861162041344298 and IMEI 2: 861162041344280 containing SIM No. 7662801632.
- (9) One APPLE Brand (iPhone) Mobile Phone bearing IMEI 1 : 354106775673657 and IMEI 2: 354106775654376 containing SIM No. 7002436041.

I, SI Sajal Roy of Matigara PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused persons namely (i) Nazrul Islam (24) s/o Hazarat Ali of vill- Baniapara, PO Garehari, PS Barpeta, Dist. Barpeta, Assam and (ii) Makabul Ali (30) s/o Lt. Abdul Rahaman of vill- Baniapara, PO Garehari, PS Barpeta, Dist. Barpeta, Assam and others to the effect that today on 08.11.2023 at 19.15 hours received a source information that five or more persons along with one Black color vehicle bearing Registration No. AS 01FA 3467 are roaming through Khoprail More Road in a suspected manner with a view to commit dacoity under Siliguri area vide Matigara PS GDE no-422 dt.08.11.23.

Subsequently, I shared the information to Officer In-charge of Matigara PS and as per his direction, I along with SI Sailesh Subba, ASI Dharendra Nath Mondal, ASI Pema Dorjee Sherpa, C/1053 Paresh Rava, C/219 Sanatan Chitrakar and CV/977 Ganesh Paswan all of Matigara PS, SPC left to verify the veracity of source information in hand by Government Vehicle.

At about 19:25 hours I along with force reached at National Highway-10 in front of Bharat Petrol Pump under Matigara PS and parked the Vehicle at considerable distance. I then called two independent witnesses namely (1) Sudipta Chatterjee S/O Malay Kr Chatterjee of Ram Krishnapara PS-Matigara Dist-Darjeeling and (2) Gopal Barman (28) S/O Jharua Barman of Ghoklajote PS-Matigara Dist-Darjeeling and met my source and waited for the vehicle to arrive there. After few minutes my source identified the vehicle which was coming towards us from the Khoprail More side and being pointed by my source I, along with force stopped the said suspected vehicle bearing Registration No. AS 01FA 3467 to verify the source information. Seeing the police personnel the three persons who were sitting on the back seat of the said vehicle and managed to fled away from the spot. While the driver and another one person along with said vehicle were detained and on being asked they disclosed their identity as noted above.

On interrogation the above noted apprehended accused persons admitted that they along with their other associates had came from Assam at Siliguri under Matigara area and where making preparation in a vehicle to commit dacoity in Siliguri area.

I along with force searched the persons and detained vehicle where the above noted seized articles were recovered from their possession. On demand they could not produced any valid documents in respect of the recovered articles.

Under the above noted circumstances it is evident that the accused persons were in preparation of committing dacoity at Siliguri area for their wrongful gain with the help of iron made steel bolt cutter & others.

I thereafter, seized the above noted articles and the vehicle under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was made in between 20.05 hours to 20.35 hours. Thereafter, I arrested the above noted two accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons appraising the ground of arrest and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they came at Siliguri area from Assam to commit dacoity in Siliguri area. It is also revealed from them that others managed to fled away with sharp cutting weapons.

Hence, a specific case may kindly be started under proper section of law against the above noted accused persons viz. (i) Nazrul Islam (24) s/o Hazarat Ali of vill- Baniapara, PO Garehari, PS Barpeta, Dist. Barpeta, Assam and (ii) Makabul Ali (30) s/o Lt. Abdul Rahaman of vill- Baniapara, PO Garehari, PS Barpeta, Dist. Barpeta, Assam and others and arrange for its investigation.
