In producing herewith the following articles under seizure :-

- (i) One nylon bag containing 25 packets of fire crackers styled as "KING KOBRA" Electric crackers, total weight 52.600 Kg.
- (ii) One nylon bag containing 18 packets of fire crackers styled as "KING KOBRA" Electric crackers, total weight 39 Kg.
- (iii) One paper made cartoon containing 30 packets of fire crackers styled as "KING KOBRA" Electric crackers, total weight 63.600 Kg

I SI Goutam Mallik of Pradhan Nagar PS do hereby lodged this written complaint against accused Ashok Saha S/O Late Hari Saha of Narmada Bagan, Road No-1, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 09.11.23 at 16.05 hrs I received a specific source information that one Ashok Saha of Narmada Bagan, PS- Pradhan Nagar, Dist.- Darjeeling stored huge quantity of illegal fire crackers at his rented room situated at Naya Busty, Kadamtala, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling. Accordingly, diarized the fact in General diary vide Pradhan Nagar PS GDE No 537 dated 09.11.23 and informed the fact to you and as per your kind order and direction myself along with SI Youle Lepcha, ASI Biplab Das, ASI Monaj Kr Roy, C/762 Majibul Islam, LC/1269 Pramila Chhetri CV/645 Pankaj Gupta, CV/223 Swapan Chhetri, CV/646 Babon Das and CV/128 Ajoy Kr Sahani all of Pradhan Nagar PS left for Naya Busty, Kadamgachh to verify the veracity of the information in hand. At around 16.25 hrs we arrived at Naya Busty, Kadamgachh, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and being identified by the source, I held raid in a house situated at Naya Busaty, Kadamtala, Champasari, PS- Pradhan Nagar, Dist. Darjeeling but seeing the police party aforesaid accused person managed to fled away from the house. Seeing the police party the landlord came out from the room and disclosed her identity as Usha Gupta W/O Raj Kumar Gupta of Naya Busty, Kadamtala, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and disclosed that one Ashok Saha S/O Late Hari Saha of Narmada Bagan, Road No-1, PS- Pradhan Nagar, Dist.- Darjeeling took one room on rent from her but she has no knowledge regarding the articles stored in the said rented room by Ashok Saha. Then, I searched the said rented room in presence of the landlord as well as local witnesses and recovered the above noted illegal fire cracker which were kept inside the room without any safety measure and without any permission from appropriate authorities and if any accident taken place due to negligent act of the accused Ashok Saha that may cause huge loss of life and property of the area. During enquiry it could be learnt that the said Ashok Saha S/O Late Hari Saha of Narmada Bagan, Road No-1, PS- Pradhan Nagar, Dist.- Darjeeling stored the said illegal fire crackers at his rented without any precautionary and safety measure and without any permission from appropriate authorities. Accordingly, I seized the above noted illegal fire crackers under proper seizure list in presence of the witnesses. The searched and seizure made in between 17.15 hrs to 19.35 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the accused namely (i) Ashok Saha S/O Late Hari Saha of Narmada Bagan, Road No-1, PS- Pradhan Nagar, Dist.- Darjeeling and arrange for its investigation.
