Sir

In producing herewith following four accused namely i) **Bikram Roy (23yrs) S/O Lt Mani Roy of Dakshin Palash Natun Bazar, PS Pradhan Nagar, Dist. Darjeeling.** ii) **Suraj Paswan (24yrs) S/O Sandip Paswan of Dakshin Palash Natun Bazar, PS. Pradhan Nagar, Dist. Darjeeling** and iii) **Md Najim (20 yrs) S/O Aktar Alam of Dakshin Palash near Birsua Munda Math, PS. Pradhan Nagar, Dist. Darjeeling** along with following seized articles viz:

- 1) One iron made sharp cutting knife and one iron rod (sabol) recovered from the exclusive possession of accused Bikram Roy.
- 2) One iron made 'Knife' and one torch light recovered from the exclusive possession of accused Suraj Paswan.
- 3) One iron made weapon called as 'Bhojali' and small torch light recovered from the exclusive possession of accused Md Najim.

I, SI Youel Lepcha S/O Jai Tshering Lepcha of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted i) Bikram Roy (23yrs) S/O Lt Mani Roy of Dakshin Palash Natun Bazar, PS Pradhan Nagar, Dist. Darjeeling. ii) Suraj Paswan (24yrs) S/O Sandip Paswan of Dakshin Palash Natun Bazar, PS. Pradhan Nagar, Dist. Darjeeling and iii) Md Najim (20 yrs) S/O Aktar Alam of Dakshin Palash near Birsua Munda Math, PS. Pradhan Nagar, Dist. Darjeeling and 8/9 others to the effect that today on 10/11/2023 at 00:05 hrs received a specific source information that 11/12 miscreants have assembled at Cooliepara near Mahananda river bed under PS- Pradhan Nagar, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Gurung Busty area. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarised the fact in General diary vide Pradhan Nagar PS GDE No.559, dated 10/11/2023 and as per order I along with SI Goutam Mallik, ASI Manoj Kr Roy, CV/645 Pankaj Gupta, CV/223 Swapan Chhetri CV/128 Ajoy Kumar Sahani, CV/992 Jagadish Biswas, CV/646 Baban Das, CV/242 Rakesh Monger all of Pradhan Nagar PS, SPC, left for Cooliepara near Mahandnda River Bed to work out the information in hand. At about 00.35 hrs we arrived at Cooliepara near Mahandnda River Bed and as indicated by the source we noticed that 11/12 persons assembled at at Cooliepara near Mahananda river bed and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 03 (three) of them with deadly weapons in their possession but 8/9 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they along with their associates were assembled there and making preparation for committing dacoity at Gurung busty area. On search the above noted weapon of offence recovered from their possession.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest and brought them to Pradhan Nagar PS. The search seizure and arrest made on 10/11/2023 in between 01.15hrs and 02.00 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons namely i) Bikram Roy (23yrs) S/O Lt Mani Roy of Dakshin Palash Natun Bazar, PS Pradhan Nagar, Dist. Darjeeling. ii) Suraj Paswan (24yrs) S/O Sandip Paswan of Dakshin Palash Natun Bazar, PS. Pradhan Nagar, Dist. Darjeeling and iii) Md Najim (20 yrs) S/O Aktar Alam of Dakshin Palash near Birsua Munda Math, PS. Pradhan Nagar, Dist. Darjeeling and others 8/9 unknown persons and arrange for its investigation.
