Sir,

I, ASI Pema Dorjee Sherpa of Matigara PS,SPC, producing hereby one accused namely Bapi Barman @ Rishi (27) S/O Jagadish Barman of Panitanki, Gandagol Jote, PO Dulaljote, PS Khoribari, Dist. Darjeeling, along with original seizure list and with seized articles do hereby lodge this complaint that today on 09.11.2023 at about 17:25 hours, a secret information vide Matigara PS GDE No 462 dated 09.11.2023, was received that one person was waiting for someone at Shiv Mandir, near NBU Gate No-2 with a Royal Enfield Thunderbird motorcycle No WB 74AU/7939. That this persons had in his possession one improvised country made firearms and ammunition and he would be delivering the same to some person. The matter was informed to O/C Matigara PS.

Following the directions of Officer In-charge myself along with ASI Dharendra Nath Mondal, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/523 Sanjit Kundu all of Matigara PS left for Shiv Mandir to verify the veracity of the source information. Enroot to the PO we also requested one independent witness namely Vishal Sarkar (24) S/O Bibhas Sarkar of Rabindra Sarani ,House no-381, near Prymary School PO-Kadamtala PS-Matigara Dist-Darjeeling to accompany us as his service would be needed during the process of search and seizure.

At around 17:45 hours we reached near Gate No 2 of NBU at Shiv Mandir and saw a person with a Royal Enfield Thunderbird motorcycle No WB 74AU/7939. Our source indicated that he was the said person. We approached the person, indentified ourselves and told him that we intended to search his person as we had specific information that he was in possession of illegal firearms.

He gave his name and address as above and we proceeded to carry out he search of his person in presence of the independent witness. During search the following articles were found on his person which he had kept concealed around his waist below his clothes.

- 1) One (01) country made improvised pistol, made of iron having the mechanism of trigger, barrel, firing pin, hammer and magazine. measuring diagonally approx 08 inch including its chamber, body, barrel, grip and black color grip panel and Marked as exhibit "A".
- (2) Two (02) pieces of live ammunition measuring approx 02.5 cm inscribed "KF" "7.65" on its base and Marked as exhibit "B"

On demand he failed to produce any document/license in support of possessing and carrying such type of fire arms and also confessed that he procured the same from Bihar for selling the same to his designated customer at Siliguri area for his wrongful gain. Thus the above noted accused person violated the provisions of arms act.

Accordingly I seized and labelled one improvised fire arms loaded with two live ammunition and One (01) Black/Red color Royal Enfield Thunderbird (two wheeler) motorcycle bearing registration No. WB 74AU/7939 from his possession under proper seizure list duly signed by him as


well as by available witnesses who were present there at that time. The seize and label was made in between 20.05 hours to 20.35 hours. I then arrested him preparing memo of arrest informing him ground of arrest

From the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused Bapi Barman @ Rishi is a desperate and dangerous person. He was carrying the said fire arms and live ammunition illegally with an objective to sell the same for his wrongful gain.


So, I pray before you that a specific case may kindly be started against the arrested accused person Bapi Barman @ Rishi (27) s/o Jagadish Barman of Panitanki, Gandagol Jote, PO Dulaljote, PS Khoribari, Dist. Darjeeling under appropriate section of law under Arms act and arrange for its investigation.
