Sir,

In producing herewith one arrested accused person namely Bablu Khan (50 years) S/O-Lt. Ainul Khan of Anchal, Iskcon 3rd gate, ward no-40, P.O.-Haiderpara, P.S-Bhaktinagar, Dist-Jalpaiguri along with following articles under proper seizure list-

1] 30(Thirty) bottles of HIMALAYAN FATAFATI 70 UP country spirit (each bottle containing 300 ml) [Total 9000 ML/ 09 L]

I, PSI Chiranjit Saha s/o-Madhab Saha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely Bablu Khan (50 years) to the effect that today on 09/11/2023 while performing my special raid duty, received a source information that one person is selling liquor in his house situated at Anchal, Iskcon 3rd gate, ward no-40 under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with SI Srimanta Chatterjee, SI Mrinal Basunia, C/374 Debraj Biswas, C/912 Nakul Chandra Singha had been to Anchal, Iskcon 3rd gate, ward no-40 under Bhaktinagar PS to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no.407, dated-09/11/23. On reaching there and as identified by the source it found that one person was selling and storing liquor in his house situated at Anchal, Iskcon 3rd gate, ward no-40 under Bhaktinagar PS. Subsequently, I along with officer and force cordoned the house and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted bottles of liquor were found in his house. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03 (Three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 15.15 hrs to 16.10 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person namely Bablu Khan (50 years) S/O-Lt. Ainul Khan of Anchal, Iskcon 3rd gate, ward no-40, P.O.-Haiderpara, P.S-Bhaktinagar, Dist-Jalpaiguri after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Bablu Khan (50 years) S/O-Lt. Ainul Khan of Anchal, Iskcon 3rd gate, ward no-40, P.O.-Haiderpara, P.S-Bhaktinagar, Dist-Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
