In producing herewith three arrested accused persons namely (1) Saroj Gurung-38yrs s/o Lt Nar Bahadur Gurung of Demdema busty, PO Salugara PS Bhaktinagar Dist Jalpaiguri (2) Amzad Hossen @ Bittu-28yrs s/o Zakir Hosen of vill Shantipara Ward No-42 PO Salugara PS Bhaktinagar Dist Jalpaiguri and (3) Subham Dutta -26yrs s/o Nilu Dutta of Near Northern flour Mill PO Salugara PS Bhaktinagar Dist Jalpaiguri (not verified) along with the following seized articles under seizure as per seizure list:

1. 22 (Twenty) bottles of RUKSCOF Chlorpheniramine Maleate & Codeine phosphate cough syrup which composition Chlorpheniramine Maleate 1P 4 MG Codeine phosphate 1P 10 MG each bottle containing 100 ML (Total-2200 ML)
2. 01 (One) transparent zipper plastic packet containing 32 (Thirty two) grams said to be Brown Sugar
3. One Motor cycle (Royal Enfield) bearing No-WB74BK/0575
4. One "ONE PLUS" mobile phone having IMEI No-865780065941552
5. One Green colour ONE PLUS mobile phone having IMEI No-862301063722010
6. One orange colour Vivo mobile phone having IMEI No-867158067894434
7. One POCO mobile phone having IMEI No-865843060973671/78
8. One Vivo mobile phone having IMEI No-869657060516256/18
9. One Black colour school bag

I, SI Mrinal Basunia s/o Manmatha Basunia of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused persons to the effect that on 09.11.23 at about 20.40 hrs, received a reliable source input that three male persons was standing at P.C.Mittal Bus stand with huge quantity of Cough syrup & brown Sugar with a motor cycle (Royal Enfield) for delivering the same to their designed customers at Siliguri area for their wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 428 dated 09.11.23 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, myself along with SI Srimanta Chatterjee, SI Rantu Halder, ASI Dipak Karmakar, ASI Chandra Prakash Adhikary, Const/374 Debraj Biswas, Const/912- Nakul Chandra Singha all are Bhaktinagar PS with investigation kit left for P.C.Mittal Bus stand under PS- Bhaktinagar by govt. vehicle to verify the veracity of the information and waiting there vide Bhaktinagar PS GDE no. 429 dated 09.11.23 and M.C.C No- 1579/2023 Dated 09.11.23.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at about 20.52 hrs we reached at P.C Mittal Bus stand and meanwhile called two independent witnesses namely; (1) Ajay Sahani s/o Lt Hari Chandan Sahani of Sahani busty, Prakashnagar ward No-43 PS Bhaktinagar Dist Jalpaiguri and (2) Nil Kumar Mukhia s/o Rohit Mukhia of Demdema busty PO Salugara PS Bhaktinagar Dist Jalpaiguri PS-Bhaktinagar Dist- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. Being identified by source our whole police party detained three persons with one motor cycle at P.C Mittal Bus stand and we disclosed our identity and the information in hand and stated them that they will be searched in persons for the purpose. At this, they disclosing their name and address as noted above. They are admitted that they have illegally possessed brown sugar and cough syrup in their possession for selling the same to their designed customers as per requirement for their wrongful gain.

I then gave them written notice to be searched in presence of Spl. Executive Magistrate. Then he agreed to be searched in presence of Spl Executive magistrate. Accordingly, I informed the matter to Sri Kartick Dey, Assistant Commissioner of Police (Traffic, HQ), SPC, as Spl Executive Magistrate, regarding the interception of the accused persons suspected to be possessed Brown Sugar, cough syrup and requested him to come at P.C Mittal Bus stand to remain present and to supervise the search and seizure.

Accordingly at 22.15 hrs Sri Kartick Dey, Assistant Commissioner of Police (Traffic, HQ), SPC, arrived at the spot as a Spl Executive Magistrate and subsequently, under his supervision in presence of witnesses the process of search of the detained persons for conducted following all formalities keeping his decency and recovered the above noted articles from the Joint possession of above noted accused persons. Subsequently, being demanded in presence of Sri Kartick Dey, Assistant Commissioner of Police (Traffic, HQ), SPC as a Spl Executive Magistrate the detained persons failed to produce any valid document in support of possessing of the brown sugar and cough syrup.

Thereafter, I weighted the recovered packet with the weighing instrument and found total 32 grams said to be Brown Sugar and 22 pcs of cough syrup which was kept in a school bag of above noted accused persons. Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses as shown by the accused persons. I also labeled and sealed all the articles in presence of Sri Kartick Dey, Assistant Commissioner of Police (Traffic, HQ), SPC as a Spl Executive Magistrate and witnesses and accused persons. The whole process of seizure was made in between 22.25 hrs to 23.35hrs.

Being further asked, the apprehend persons namely (1) Saroj Gurung-38yrs s/o Lt Nar Bahadur Gurung of Demdema busty, PO Salugara PS Bhaktinagar Dist Jalpaiguri (2) Amzad Hossen @ Bittu-28yrs s/o Zakir Hosen of vill Shantipara Ward No-42 PO Salugara PS Bhaktinagar Dist Jalpaiguri and (3) Subham Dutta -26yrs s/o Nilu Dutta of Near Northern flour Mill PO Salugara PS Bhaktinagar Dist Jalpaiguri

admitted in presence of Sri Kartick Dey, Assistant Commissioner of Police (Traffic, HQ), SPC and other witnesses that he procured the brown sugar and cough syrup clandestinely from elsewhere for the purpose of selling the same in high rate to their designed customer for their personal gain by illegal means. They also disclosed that they have been dealing in such business of procuring and selling of brown sugar and cough syrup illegally for last few months.

Then, I arrested the above noted accused persons namely (1) Saroj Gurung-38yrs s/o Lt Nar Bahadur Gurung of Demdema busty, PO Salugara PS Bhaktinagar Dist Jalpaiguri (2) Amzad Hossen @ Bittu-28yrs s/o Zakir Hosen of vill Shantipara Ward No-42 PO Salugara PS Bhaktinagar Dist Jalpaiguri and (3) Subham Dutta -26yrs s/o Nilu Dutta of Near Northern flour Mill PO Salugara PS Bhaktinagar Dist Jalpaiguri after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons are involved in procuring and selling of brown sugar and cough syrup illegally contravening the norms of NDPS Act. The whole process during search, seizure and arrest was video graphed by the videographer Sri Nitai Chowdhury of Shivarampally, Haiderpara PS Bhaktinagar Dist Jalpaiguri.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Saroj Gurung-38yrs s/o Lt Nar Bahadur Gurung of Demdema busty, PO Salugara PS Bhaktinagar Dist Jalpaiguri (2) Amzad Hossen @ Bittu-28yrs s/o Zakir Hosen of vill Shantipara Ward No-42 PO Salugara PS Bhaktinagar Dist Jalpaiguri and (3) Subham Dutta -26yrs s/o Nilu Dutta of Near Northern flour Mill PO Salugara PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
