3. I had around Rs 150000/- (Rupees One lac fifty
thousand only) with me which I had kept for
meeting my expenses. This I had kept in

4. On 07 Nov 2023 at around 0830 hrs I woke up and asked Sasanka Manna to get a glass of tea. He got the tea around 9 am. When I was about to take my tea, I casually checked my bag, I was shocked to learn that there was no money in the bag. I enquired about Mohd Imran's whereabouts as I could not see him. I learnt he was not present in the hotel / lodge. On ringing up his mobile, he did not attend to the call. Thereafter I tried to contact him a number of times, but he did not respond. I suspect he has stolen the money and fled. In view of the above it is requested that an FIR be lodged against the individual and suitable action be initiated against him at the earliest. 
