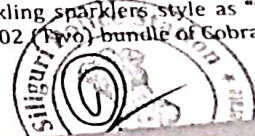

Sir,

With due respect, I am producing herewith the arrested accused person namely Indrajit Saha (23) s/o Nilhil Sha of Hakimpara, Rajaram Mohan Road, Ward No.- 15, PS-Siliguri, Dist.- Darjeeling and the following articles under seizure :-

- (i) 06 (Six) bundle of Rhino Power Chocolate Bomb containing 05 packets in each bundle.
- (ii) 03 (Three) bundle of Electric Sparkel containing 10 packets in each bundle style as "SRI VAARU".
- (iii) 03 (Three) packets of Magix Wrinkle Sund containing 50 (Fifty) pices in each packets style as POP.
- (iv) 04 (Four) packets of Crakling sparklers style as "SRI VAARJU".
- (v) 02 (Two) packets of Ground Chakkar containing 45 pices in each packets.
- (vi) 02 (Two) bundle of Cobra 28 Chorsha Fire Crackers containing 48 packets in each packets.

I, ASI Surojit Mallick of Panitanki TOP, under Siliguri PS, Siliguri Police Commissionerate do hereby lodged the written complaint against the above noted arrested accused person to the effect that today i.e. on 8.11.2023 at 1 am detailed to perform Motor Cycle duty under Panitanki TOP, under Siliguri PS, Dist.- Darjeeling vide MCC No.- 1130 dated: 08.11.2023 vide Panitanki TOP GDE No.- 181 While performing Motor Cycle Mobile van duty at about 1805 hrs I received a secret information that one person namely Indrajit Saha (23) s/o Nilhil Sha of Hakimpara, Rajaram Mohan Road, Ward No.- 15, PS_ Siliguri, Dist.- Darjeeling is selling contraband fire crackers at his shop styled as Nikhil Store for his illegain gain. Accordingly, I diarised the fact in General diary vide Panitanki TOP GDE No.- 181 dated: 08.11.2023 and informed the fact to Officer-In-Charge, Panitanki TOP, you as well to you. As per kind order and direction of my superior Officers myself along with others available officers and force namely ASI- Lakhan Kumar Singha, C/114 Nagendra Nath Roy, left for Rajaram Mohan Roy Road, under Siliguri PS, Siliguri Polie Commissioenrate to work out the information in hand. At about 18.35 hrs we arrived at Raja Ram Mohan Roy Road, Hakimpara, WarD No.- 15, PS- Siliguri, Dist.- Darjeeling and being shown by the sourece I held raid at Nikhil Store, and managed to apprehended the owner of the above noted shop. On search the above noted contraband Fire crackers recovered from his shop. On demand he failed to produce any valid documents in respect of the above noted contraband Fire crackers. During physical verification it is also found that the said illegal contraband fire crackers kept in his shop without any precautionary and safety measure. Accordingly, I seized the above noted illegal contraband fire crackers under proper seizure list and arrested the owner of the shop namely Indrajit Saha (23) s/o Nilhil Sha of Hakimpara, Rajaram Mohan Road, Ward No.- 15, PS-Siliguri, Dist.- Darjeeling under proper memo of arrest and observing all the formalities of arrest. The search and seizure made in between 1835 hrs to 1915 hrs on 08.11.2023.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused person namely Indrajit Saha (23) s/o Nilhil Sha of Hakimpara, Rajaram Mohan Road, Ward No.- 15, PS-Siliguri, Dist.- Darjeeling and arrange for its investigation.
