Sir, With due respect, I am producing herewith the arrested accused person namely Bidu Bhusan Ghosh (62) s/o Shri Krishna Chandra Ghosh of Hakimpara, Atul Prasad Sarani, Ward No.- 15, PS- Siliguri, Dist.- Darjeeling and the following articles under seizure :-

- (i) 07 (Seven) packets of JUGMUG Chocolate Junior containing 12 piceses in each packets.
- (ii) 05 (Five) packets of Folwer Pots Deluxe Turkey containing 10 piceses in each packets.
- (iii) 03 (Three) packets of Akash Gnaga Tubri containing 05 Pices in each packets.
- (iv) 01 (One) Angry Birds Fire Crckerks style as "Krishna" 12 shots.
- (v) 01 (One) packets of Fireworks containing 03 shots in one packets style as "Blossom".
- (vi) 01 (One) packets of Fire Works Tubri contining 10 piece in each packet.
- (vii) 01 (One) packets of Color Koti Tubri containing 10 Pices in each packets.

I, SI-Uday Shankar Mandal of Panitanki TOP, under Siliguri PS, Siliguri Police Commissionerate do hereby lodged the written complaint against the above noted arrested accused person to the effect that today i.e. on 8.11.2023, at about 1955 hrs I received a secret information that one person namely Bidu Bhusan Ghosh (62) s/o Shri Krishna Chandra Ghosh of Hakimpara, Atul Prasad Sarani, Ward No.- 15, PS- Siliguri, Dist.- Darjeeling is selling contraband fire crackers at his shop styled as Bidhu Pan Ghar for his illegain gain. Accordingly, I diarised the fact in General diary vide Panitanki TOP GDE No.- 184dated: 08.11.2023 and informed the fact to Officer-In-Charge, Panitanki TOP, as well as to you . As per kind order and direction of my superior Officers myself along with others available officers and force namely ASI Biswajit Saha, C/114 N. Hazda, left for Atul Prasad Sarani, under Siliguri to work out the information in hand. At about 2015 hrs we arrived at Atul Prasad Sarani, Hakimpara, WarD No.- 15, PS- Siliguri, Dist.- Darjeeling and being shown by the sourece I held raid at Bidhu Pan Ghar, and managed to apprehended the owner of the above noted shop. On search the above noted contraband Fire crackers recovered from his shop. On demand he failed to produce any valid documents in respect of the above noted contraband Fire crackers. During physical verification it is also found that the said illegal contraband fire crackers kept in his shop without any precautionary and safety measure. Accordingly, I seized the above noted illegal contraband fire crackers under proper seizure list and arrested the owner of the shop namely Bidu Bhusan Ghosh (62) s/o Shri Krishna Chandra Ghosh of Hakimpara, Atul Prasad Sarani, Ward No.- 15, PS- Siliguri, Dist.- Darjeeling under proper memo of arrest and observing all the formalities of arrest. The search and seizure made in between 2115hrs to 2155 hrs on 08.11.2023.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused person namely Bidu Bhusan Ghosh (62) s/o Shri Krishna Chandra Ghosh of Hakimpara, Atul Prasad Sarani, Ward No.- 15, PS- Siliguri, Dist.- Darjeeling and arrange for its investigation.
