Sir,  
With due respect, I smt. Laxmi Das @ Sagai Das, w/o Sri Dilip Das, resident of Tyoti Nagar Colony, Ward No. 4, P.O & P.S - Siliguri, Distt - Darjeeling, would like to inform you that, on dt. 06.11.2023 at about 11:00 AM, when I was busy with my household works, at that time one Ranbir Das s/o Santosh Das, and his mother, Nitu Das w/o Santosh Das, came to my home and without any rhyme and reason, have picked up hue and cry & started threatening to leave my husband and leave the house and when I raised my objection, they became furious and have started assaulting me by iron rod & fist & blows resulting which I sustained serious injuries on my part and after raising my hue & cry, Santosh Das s/o Late Prian Bandhu Das also came to my home and when I shown my injuries to said Santosh Das, Samiran Das of he instead of controlling his wife and son, has lifted my saree in the name of seeing my injuries at my right thigh and forcefully pushed his hand to my private part and when I have raised my objection, the said Ranbir Das has caught me from back side by putting his hand on my breast and started smacking my breast and upon my abuse to both of them, the said Santosh Das brought a rod and Nitu Das by holding stone have started assaulting me & Ranbir Das has torned off my blouse resulting which my upper part of body became clothe less. To protect my modesty and to save my life, when I have started screaming, all the above named three persons have left me in injured condition. After the said incident, I had been to hospital for treatment that above named Santosh Das & Ranbir Das have threatened me for dire consequences, so please take necessary action.
