That one person namely Satyam Bhandari, s/o Joydev Bhandari, 18.11.23 1/2-406/ permanent resident of Ramjivanpur, South 24 Parganas, PINand the 743354, in the State of West Bengal, presently residing at nedde 23 Dindo Dabgram, Bhajan Ghosh More, near Hanuman Mandir, Ward No. which control 22 of S.M.C., P.O. & P.S.-Siliguri, Dist.-Darjeeling, working as for The Investme Branch Manager of Asirvad Micro-Finance LTD, since last 7-Smonths at Fulbari Branch (bearing branch code no. 5606).

That the above-named person Satyam Bhandari is responsible for Office Report P.D.O. i.e., Field Development Officer and after the process of all the collection money from the loan borrower as collected by the collected amount is being deposited to the concerned Bank.

That on 18/10/23 and 19/10/23 Fulbari Branch has collected a sum of Rs. 7,26,512/- (Seven Lacs Twenty Six Thousand Five Hundred and Twelve) by the F.D.O and the same has been handed over to the Branch Manager namely Satyam Bhandari for verification and deposited the same amount to the concerned Bank. But the collected amount of 18/10/23 and 19/10/23 is not being processed and deposited by the Branch Manager for which he is responsible for.

That on 20/10/23 when the other staffs of the said Branch reached the office they found out that the keys were laying on the 13

staircase and soon after that they informed me and the Branch Manager was found absent on work on that day. After various calls to the Branch Manager namely Satyam Bhandari and his wife but both of their phone is in switch-off mode and thus we cannot contact with them.

That after entering into the office we have found that on the Branch Manager's cabin, the locker was opened and the cash amounting to Rs. 7,26,512/- (Seven Lacs Twenty Six Thousand Five Hundred and Twelve) was missing. Soon after I have informed to the Regional Manager namely Iftekar Alam, Vigilance Manager namely Pintu Pathak, Audit Manager namely Uttam Adhikary and Sanjit Bose. After various enquiry and from the landlord of the building where the office is situated, we came to know that Satyam Bhandari, the Branch Manager of Fulbari Branch asked for the keys for opening the main gate from the landlord itself by giving the excuse that he (Satyam Bhandari) mistakenly left his home keys at his cabin for that he needs to enter into the office at night at around 11P.M. and without informing the landlord, he left the office keys on the staircase of the said building.

That after the said incident, I along-with other staffs of the office went at the residence of the Branch Manager and found out that he left his rented house with his family. Moreover, his motor-bike (Honda Shine) bearing registration no. WB-98-C-2066 has been found out at the parking of N.J.P. Railway Station.

That it is my strong believe that the said amount has been dishonestly kept under his custody and the Branch Manager has committed fraud towards the company and the customers of the said branch.

Therefore, in the above-mentioned circumstances I request your kind office to take proper necessary legal action against the alleged persons with strict provisions of Penal Law. Your kind attention will be highly solicited for same.
