3. 01 (one) plastic ground sheet.


I, ASI Khagen Barman, presently attached with NJP PS, SPC under your kind control beg to state that on 08.11.23, during my night mobile van duty, at about 23.45 hrs received an information that a team of gamblers assembled at Nouka Ghat More association office and playing gamble in exchange of money. Accordingly, I inform the matter to you and as per your kind direction myself along with ASI Dhruva Mishra, C/453 Uttam Dey, CV/306 Biswajit Roy all of NJP PS, SPC left Noukaghat More to work out the information in hand Ref. NJPPS GDE No. 386, dated- 08.11.23. On 08.11.23 at 23.55 hrs we arrived at Noukaghat More Association office under NJPPS, SPC and found 14/15 persons were playing gamble in exchange of money. Seeing the Police team some gamblers were fled away. Accordingly I arrested the present persons from the spot as noted above maintaining all formalities and seized Rs. 5,050/- as board money, 02 (two) packets of Playing cards, 01 (one) plastic ground sheet from their possession. The whole process of search & seizure was made in between 00.05 hrs to 00.35 hrs on 09.11.2023.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of law may kindly be started against the accused persons namely 1) Mahinder Sahani (34), S/o- Lt. Binda Sahani of Rajaholi, PS- NJP, Dist- Jalpaiguri, 2) Shankar Broto Bagchi (38), S/o- Kamakhya Bagchi of Shaktigarh, Road No. 2, PS- NJP, Dist- Jalpaiguri, 3) Uttam Ghosh (40), S/o- Parimal Ghosh of Noukaghat More, Netajee Colony, PS- NJP, Dist- Jalpaiguri, 4) Gopal Paul (35), S/o- Lt. Jadab Paul of Shaktigarh, PS- NJP, Dist- Jalpaiguri, 5) Srijit Das (34), S/o- Shyamalendu Das of Ashok nagar, PS- NJP, Dist- Jalpaiguri and 6) Dipesh Mohanta (49), S/o- K. L. Mohanta of Sarkarpara, Sevok Road, PS- Bhaktinagar, Dist- Jalpaiguri and others and arrange for its investigation.
