I Subhash Nag S/O – Late Birendra Nagresident of Ambika Chakraborty Sarani , South Bharat Nagar, Ward No -24, Siliguri, Dist – Darjeeling beg to state as follows:-

That I am a Cancer Patient presently under thetreatment of Tata Memorial Hospital, Mumbai. That I am the joint owner of the below scheduled land along with Mr. Sandip Ghosh S/O -Gobindo Pada Ghosh by virtue two separate Deeds of Sale being number – 7303 for the year 2014 and 7313 for the year 2014 registered at the A.D.S.R Rajganj, executed by Pawan Roy and Menoka Roy since the purchase we were enjoying the absolute, khas and physical possession of the below scheduled land that after the purchase of the land we mutated our name & opened two separate LR khatian being no -199 and 161 in our name. Since purchase Akshay Kumar Roy @ Kalu Roy S/o – Late Kishori Mohan Roy, Niranjan Roy S/o – Late Kishori Mohan Roy and Abinash Roy S/o – Late Kishori Mohan Roy all of them are local residents in the area of my below scheduled land they are land grabbers and are linked with many local anti - socials and by their act and activities with reference to the land in the locality they are known as notorious land grabbers, in many occasions they had tried to grab my land illegally & forcefully with the help of the local people we have managed to restrained them but a tension was there in the locality, for which there was reasonable apprehension for breach of peace and disturbance of public tranquility therefore we had filed a case in the court of the Ld. Sub Divisional Executive Magistrate at Jalpaiguri being case no - 1009/2022 against Akshay Kumar Roy @ Kalu Roy S/o - Late Kishori Mohan Roy, Niranjan Roy S/o - Late Kishori Mohan Roy and Abinash Roy S/o - Late Kishori Mohan Roy under section 144 CrPC, after hearing the petition the Ld. Court has passed the restraining order against the above named notorious persons. That order has been duly intimated to them. Yesterday on 09/11/2023 suddenly at about 4pmfew people namely Joydev Roy S/o – Akshay Kumar Roy, Akshay Kumar Roy S/o – Late Kishori Mohan Roy Niranjan Roy S/o – Late Kishori Mohan Roy, Lakhindar Roy S/o – Late Kishori Mohan Roy, when I was working at my land with some laborers, the above named notorious persons entered into our land premises with many weapons like Bamboo, Iron Rod, Wooden Lathi and threatened me and my laborers to leave the land, then they started destroying the fencing of our land & other ongoing construction works. When I raised objection they started using filthy languages then those notorious people started hitting me with fists & blows they brutally Slapped & kicked me then I fell down on the land and then they hit me by Bamboo,
