Sir,

I, SI Basudeb Guha of Siliguri Police Station, Siliguri Police Commissionerate do hereby producing the arrested accused person namely Shambhu Das(38), S/O-Lt. Gobinda Chandra Das of Phuleshwari Unnayan Colony, Ward No-20, P.S- Siliguri, Dist. Darjeeling owner of Deep Bhandar, along with seized Fire crackers viz; i] 10 packets Mohan's 15 CM Colour Sparklers ABC, manufactured by Mohan Industries. ii] 12 packets Mohan's 30 CM Green Premium Sparklers, manufactured by Mohan Industries, iii] 08 packets Mohan's 15 CM Electric Premium Sparklers, manufactured by Mohan Industries, iv] 30 packets Mohan's Maya Electric Sparklers, manufactured by Mohan Industries, v] 06 packets Jawan RED Sparklers 15 CM manufactured by Sivakasi(T.N) vi] Akash Ganga Brand, Green Classic Light 15" 03 packets each packets containing 10 pieces vii] 25 Crackling Shots 02 packets manufactured by Green Fireworks, viii] 03 packets Star War, ix] Puja King Gfisher - 10 manufactured by Puja Traders 04 packets each packets containing 10 pieces, x] Jawan BIG Flower Pots 14 packets each packets containing 10 pieces, xi] SS TIP Top Unlimited Fun manufactured by Sivakasi 20 packets each packets containing 10 pieces, xii] Krishna Regd Super Spinner manufactured by The Aruna Fireworks Industries, 07 packets each packets containing 10 pieces, xiii] Jawan Flower Pots Special 05 packets each packets containing 10 pieces and xiv] Ginny Sanchita 3 Colour Light Silver Red Green White manufactured by Sanchita Fireworks 12 packets, under seizure as per seizure list. In this regard I beg to complain that today i.e 11.11.2023 at 18.15 hrs received a secret information over telephone that one Shambhu Das shop owner of Deep Bhandar of Phuleshwari Unnayan Colony under PS Siliguri have been storing and selling Fire-crackers without having any license or other valid documents violating the provision of law, which may endanger of human life, likely to cause injury and may cause loss of public property of the area. This refers to Siliguri PS GDE No. 861 dated 11.11.23. Accordingly, I informed the matter to I/C PS. As per your kind order I accompanied with ASI Debasish Das, ASI- Subir Sen, CV/622 Ramanath Barman and CV/283 Prasenjit Dey rushed to the spot to work out the information. On reaching at Phuleshwari Unnayan Colony I contacted with source and as shown by source cordoned the Deep Bhandar .

Accordingly, I called two disinterested witnesses of the locality namely (1) Sanjay Roy (52), S/O- Lt. Sitanath Roy of Subashpally, W/No-20, PS- Siliguri, Dist- Darjeeling and (2) Raj Das(22), S/O- Goutam Das of Subashpally, W/No-20, PS- Siliguri, Dist- Darjeeling and


conducted raid in the said Deep Bhandar of Shambhu Das. On being searched I recovered above noted fire-crackers from the Deep Bhandar. On being asked regarding storing and selling Fire Crackers he could not produce any valid documents/licenses in support of the possession of such quantity of Fire Crackers recovered. It is pertinent to mention herein that the shop of above noted accused namely Shambhu Das is situated in the densely populated area, the accused was carrying such illegal business of fire crackers without any safety measure and without any permission from appropriate authorities, if any accident took place due to negligent act of the accused person that may cause loss of life and property of the area. The Fire crackers were stored without any precautionary and safety measure, thereby, violating the Section 285/286 of IPC and Section 24 of WBFS Act. Accordingly, I seized the fire crackers under proper seizure list duly signed by the witnesses and acknowledge by the accused person. Accordingly, I arrested the above noted accused persons U/S 41 Cr.P.C.

Under the above circumstances, I pray before your kind end to start a specific case against Shambhu Das(38),S/O-Lt. Gobinda Chandra Das of Phuleshwari Unnayan Colony, Ward No-20, P.S- Siliguri, Dist. Darjeelin and arrange for its investigation.
