Sir,

In producing herewith two arrested accused persons namely (1) Lalu Sha -63yrs s/o Lt Patiraj Sha of Netajinagar, ward No-42, PS Bhaktinagar Dist Jalpaiguri and (2) Indrajit Paul-38yrs s/o Lt Gangadhar Paul of Dimdema Busty, PO Salugara, PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- (1) 09 (Nine) packets of RHINO power chocolate each packet containing 10pieces
- (2) 03 Pcs of Night Champion (One shot) Fire crackers
- (3) 10 Pcs of Mega silver pots, manufactured by the Aruna Fireworks industries
- (4) 100 packets of King Cobra fire crackers manufactured by Sri Narayana Fire work, Sivakashi,
- (5) 88 (Eighty eight) packets of Cobra Gold chors crackers manufactured by Sri Ayushman Pyro works agency [SL 1 & 5 =Total-12 Kgs]

I beg to report that I, ASI Dipak Karmakar s/o Lt Dulal Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complaint against the above noted arrested accused person to the effect that on 11.11.23 at about 15.15hrs received secret source information from Dimdema busty that two persons stored and selling huge quantity of band fire crackers at Dimdema busty under Bhaktinagar PS. Diarized the information in GD vide Bhaktinagar PS GDE no-518 dated 11.11.23 and as per your kind instruction myself along with SI Mrinal Basunia, PSI Koushik Raha, C/912 Nakul Singha, CVF/935 Biplab Roy left for Dimdema busty to work out the information.

At about 15.50 hrs we reached at Dimdema busty, sometimes after, being identified by the source our police party held raid in the shop of above noted persons and recovered the above noted articles from their shop. On demand they could not produce any valid documents/license in support of said fire crackers and also stated that they were selling the band fire crackers in his shop without any valid documents or license violating the provision of law which may endanger human life and likely to cause hurt or injury human or property. Accordingly I seized the above noted fire crackers in presence of witness duly signed by him from the possession of (1) Lalu Sha -63yrs s/o Lt Patiraj Sha of Netajinagar, ward No-42, PS Bhaktinagar Dist Jalpaiguri and (2) Indrajit Paul-38yrs s/o Lt Gangadhar Paul of Dimdema Busty, PO Salugara, PS Bhaktinagar Dist Jalpaiguri and arrested them u/s 41 Cr.pc. (The seizure was made in between 16.30 hrs to 17.20hrs)

I therefore request you a specific case may kindly be started against the accused persons namely (1) Lalu Sha -63yrs s/o Lt Patiraj Sha of Netajinagar, ward No-42, PS Bhaktinagar Dist Jalpaiguri and (2) Indrajit Paul-38yrs s/o Lt Gangadhar Paul of Dimdema Busty, PO Salugara, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for its investigation.
