Dear Sir,

I, Smt. Shefali Biswas (Sarkar), Wife of Sri Nripen Biswas, Daughter of Late Narendranath Sarkar, presently residing at C/o Sri. Tarapada Adhikary, Samarnagar, Champasari, P.O & P.S:- Pradhan Nagar, District- Darjeeling at the outset I would like to inform you the following facts and circumstances. I got married to Sri Nripen Biswas, Son of Sri. Niranjan Biswas, Resident of Resident of C/o Samir Ahmed Khan, H No.209, 520 Malan Masi Balaji Ke Piche, Javahar Colony, Ward No. 32 ka hissa, Tehsil-Bundi, District Bundi, Rajasthan-323001 also available at C/o Nirajan Biswas, opposite gas factory, Vill. Gazole, Kodubarimore, P.S.- Gazole, District-Malda. Contact No.9694645621, according to Hindu rites and customs on 25.10.2012. Soon after the marriage, we started living as husband and wife at the parental residence of my husband at C/o Nirajan Biswas, opposite gas factory, Vill. Gazole, Kodubarimore, P.S.- Gazole, District-Malda and that after 3 (three) months we shifted to a rented accommodation of my husband at Bundi, Rajasthan as the clinic of my husband was situated there. It is pertinent to mention here that my husband is engaged as a physician at his own owned clinic namely, "Navjeevan Clinic" situated at Meera Gate, Balaji Road, Bundi, Bundi Ho, Bundi - 323001. That soon reaching there I realized that my husband is a habitual drunkard and was extremely stingy and impractical. He often used to leave the house without providing me any money for expenses and expected me carry out the household duties with whatever little groceries he used to buy. He often used to bring his friends at the said rented accommodation on a regular basis. When I confronted him about it he used to physically abuse me and stated that his behavior is justified as I did not bring enough dowry from my paternal house at the time of marriage. These activities became regular in our house and our house used to be filled with his friends who were always in an intoxicated manner, and were always found underclothed inside the house due to which I raised a lot of objections but I was silenced by my husband by hitting me with fists and blows. Even the local people came to confront my husband to stop these

kinds of activities as the same is deranging the environment. On June, 2015 I was detected pregnant but my husband did not change his ways he completely neglected the natal care and I often went to the doctor alone he never used to provide any good food or care required for the growth of the baby. He even started sleeping separately in another room at night and used to chat with other girls and avoided any form of sexual intimacy with me. He often used to pressure me for aborting the child but I did not allow the same to happen even after repeated mental atrocities committed upon me by my husband. Often times he and his parents put me under constant pressure to birth a boy child or else they will not accept any girl child. After sometime I realized that my husband often used to chat with other girls on his cell phone on various social media platforms which made me confront him about the same but he bluntly told me, "nijeke dekho tomake dekhe mone hoy tumi amar joggo; tomar theke bhalo mey k ene ami biye korbo" after listening to these horrific words from my husband's mouth I confronted him that he cannot do this as I am his legally married wife I even approached my sister in law who along with her husband (my brother in law) confronted my husband after I showed them his illicit chats with other women but he outrightly rejected to listen to anyone. I also intimated the same to my in laws but they supported their son instead of giving him good advice. When my sixth month of pregnancy was going on my husband asked me to go to my matrimonial house at C/o Nirajan Biswas, opposite gas factory, Vill. Gazole, Kodubarimore, P.S.- Gazole, District-Malda. I obliged his wishes and went there but no one took care of me there also and I was made to work like a maid servant. My sister in law's husband also used to torture me while I used to take a bath he used to purposely go to my room and sleep there on objecting my mother in law did not confront him at all and said he is like a son to us we will not say anything you should change I my room. Due to being in constant household work pressure and suffering various kinds of atrocities my health started deteriorating in the matrimonial home at Gazole so I requested my parents to come and take me to my parental house. At the time delivery my parents called my husband but he did want to come for delivery. My parents took me to the hospital but there we were informed that my health and the baby' health was compromised as the doctor suggested that they may only be able to save either me or my baby still after receiving the said information my husband did not bother to come to see me rather when he was called he stated to my mother in the most rude manner that he will not pay any medical bills and further shouted that "apnar mey more gele amader malda r bari te body pathaben na apnar okhanei purae diben" my mother was utterly shocked after receiving such reply form my husband. After the operation finally a girl child was born on 29.01.2016. I thought that after the birth of our child my husband would change his ways but unfortunately all my hopes were in vain. In order to reconcile with my husband for the sake of my child I went back to my husband to stay with him in Bundi at the rented place. Even after the birth of our child the illicit behavior of my husband did not change he rather out rightly started chatting and maintaining his illicit relations in front of me. He even threatened me that if I did not leave him he will kill me and throw my body somewhere my family would not be able to find me.

When I confronted him on this he told me that even in the past his paternal aunts were also forced to commit suicide for not bringing enough dowry. I was shocked after hearing this. In spite of receiving such death threats I could not muster the courage to leave the house as I and my child were completely dependent on him for everything. After staying there for a prolonged period of time I had to suffer a lot of atrocities which were also witnessed by the niece of my husband namely Mandira who had visited us in Bundi sometime in the 2017 even she saw the utmost atrocities committed on me by my husband and often times she used to witness her uncle beating me mercilessly and she used to get so scared that she used to tell me to leave her uncle and go back to my paternal house. One night when I was sleeping with my baby and my husband's niece I abruptly woke up and I saw my husband with a pillow in his hand completely drunk and standing right beside me I was completely shocked and I shouted and told him to get away from me the niece saw the entire incident. My husband was so aggressive in nature that he used to threaten to kill me everyday. On every alternative day my husband used to abuse me physically and mentally and demanded money. On several occasions, I told my laws about the same but they did not object to his actions. I along with my family members tried to convince him to get rid of this ill habit but in spite of it he did not pay heed to any request of ours. Ultimately, having suffered with such unbearable situation in the month of November of 2021, I was compelled to leave the my matrimonial home leaving all my belongings and jewellery and stridhan at my matrimonial house and then I shifted to my relatives home at Champasari, Siliguri with my girl child. After coming back here my husband did not try to contact me once when I or my family members tried to contact him he abruptly stated that he does not want to talk. Only when he needed money he contacted me and told me to send money somehow I contacted my brother and asked them to help me and with their help I had sent some money to my husband and some money to my in laws as well but their behavior did not change they kept demanding money but I finally refused to give them more money so they stopped contacting me or my family members. Recently in the month of February, 2023 I was informed by one of the locals of Bundi who knew me and my husband informed me that my husband has conducted another marriage and that woman is now pregnant. Upon receiving the said information I immediately rushed to Bundi along with Younger brother and Advocate Mohammad Murad to find out the truth and upon reaching there I could not believe what my eyes saw. We saw that my husband had married another woman namely Rinka Biswas and she was pregnant and upon seeing her it looked like she was approx. 6 (six) months pregnant. When I confronted my husband he most aggressively told me that if I take any steps against him he will kill me along with our child. I left from there disheartened and hopeless, upon coming here my family members also reached out to my husband but he did not talk to them and kept threatening that if I take any steps against him he will kill me and my baby. I also informed the same to my laws but the same fell on deaf ears as they did not take any steps against my husband. After overcoming my trauma and shock I finally gathered courage to

take steps against him and file this present complaint as I was under dire threat of untoward circumstances.

I therefore inform you with the facts and circumstances as enumerated herein above. I hence request you to book the aforesaid culprits namely my husband Sri Nripen Biswas, Son of Sri. Niranjan Biswas, Father-in-law-Niranjan Biswas, Mother-in-law -Deepali biswas, Brother-in-law Nishit Biswas, (sister-in-law husband) Subhir, (sister-in-law) Mamoni Biswas under appropriate provisions of law.

This is for your kind information and necessary action.
