'Respected Sir,

With due respect I, Suvendu Ghosh, Son of Late Ranjit Kumar Ghosh, resident of Mother Teresa Sarani, Babupara, Post Office -Siliguri Bazar, under Police Station -Siliguri, District -Darjeeling, would like to inform you that on 13/11/2023 at about 00:00 hours (i.e., midnight of 12/11/2023), I was present at the Kali Puja Mandap/Pandal within the precincts of Babupara Boys Club which is just opposite to my residential house. At such time, when I was enjoying the festivities of Kali Puja and Diwali there, one Nani Gopal Dhar, Son of Asutosh Dhar, resident of Aswani Kumar Dutta Sarani, Ashok Nagar, near Chalantika Kali Mandir, Post Office -Siliguri, under Police Station -N.J.P., District -Jalpaiguri, who is also the owner of Grand Bar situated at Tinbatii More and a popular hoodlum in and around Siliguri and its adjacent areas, arrived there with premeditated motive to commit my murder and with such spite, all of a sudden and without any provocation, he attacked me by a Sharp Cutting weapon (Ustara) acutely and pointedly targeting to cut my throat for committing my murder. By the sudden reflex action of my body sensing such danger, I could somehow got saved from his attempt of cutting my throat for committing my murder, which missed by an inch only, but his such blow by the said Sharp Cutting weapon (Ustara) inflicted a deep sharp cut grievous injury in my right hand wrist during the reflex action of my body. Witnessing this, all the persons present there started shouting for which he got timid for a while and I managed to run away from the spot and entered my house which was just at the opposite.

Later, the next day I was medically treated but due to the tremendous trauma and shock along with the sense of immense insecurity I suffered by the incident which occurred just opposite to my house, a delay has been occasioned in lodging this complaint. Therefore, kindly set the law of the land in motion and do the needful.
