
(i) 06 (Six) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 ML in each bottle and value of Rs 130/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

(ii) 10 (Ten) bottles of 'Himalayan Fata Fati 70 UP' Country Spirit containing 300 ML in each bottle and value of Rs 40/- of each bottle and marked as "Exhibit- "B" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit B-1".

I, SI Pijush kanti Sen Sarkar of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Nitish Chakraborty (53 yrs), S/O- Lt. Nitai Chakraborty, of Indira Pally, Shivmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling to the effect that on 10.11.2023 at 19.15 hrs received a source information that one person named Nitish Chakraborty (53 yrs), S/O- Lt. Nitai Chakraborty, of Indira Pally, Shivmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling is selling liquor at his shop situated near AINU Hospital, Shivmandir under Matigara PS jurisdiction without any valid license. Shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to the shop of the above noted accused to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the shop of accused Nitish Chakraborty (53 yrs), S/O- Lt. Nitai Chakraborty, of Indira Pally, Shivmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his shop without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from the shop of the said accused. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labelled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Nitish Chakraborty (53 yrs), S/O- Lt. Nitai Chakraborty, of Indira Pally, Shivmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling after observing all sorts of formalities. The whole process of seizure and label has been made on 10.11.2023 in between 20.05 hrs to 20.35 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused Nitish Chakraborty (53 yrs), S/O- Lt. Nitai Chakraborty, of Indira Pally, Shivmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
