Sub: Written complaint

Respected Sir/Madam,

With due respect, I, Sri Kaushik Das, son of Sri Amar Ananda Das, resident of Ramkrishna Nagar, Siliguri J.N., P.O. & P.S.- Pradhan Nagar, Dist. - Jalpaiguri, beg to inform you that today, i.e. on 14.11.2023 at about 1.00 a.m. I alongwith my two friends, Tubai Barman, son of Lalchand Barman and Tanmay Saha, son of Swapan Saha both are my neighbor was returning in a vehicle, having registration no. WB74AG3322 (Wagnor) from Planet Mall towards Iskam Mandir Road, all on a sudden a White Coloured Scorpio Vehicle came from left side and tried to overtake us and on this run the said vehicle thrashed our vehicle and thereafter stopped a few steps ahead and then 7/8 persons came out from the said Scorpio and chased us and started hot altercation and when we tried to call to the Police Station they left the spot.

Thereafter we went to Ashighar More to attend a Puja and when we were returning from there the abovenoted vehicle (Scorpio) was standing at the front of Dhakeshwari Kali Mandir and seeing us all of the persons within the vehicle came out and stopped us and asked us to come out of the vehicle and when we came out all of them (7/8 in numbers) started assaulting us brutally and in the meantime 2-3 persons took out Hokey Stick, "wooden buttam" and bamboo sticks from their vehicle and started beating us ruthlessly with those and one of them took a heavy stone from the road side and tried to throw the same on my head however somehow I saw his attack and manage to save my head thereafter said person throw the said stone to the back glass of my vehicle and thereafter hold head of my friend Tubai and stabbed his head to the side glasses of my vehicle and in the meantime I saw one of them trying to stab me with a knife and others encouraging him with the word "Khatam kare de shalake", however I

quickly stayed away and in the meantime one Police Van came there due to which they quickly left the spot but before getting in the car one of them snatched my gold chain (weighing 23.878 grams, having Tax Invoice No. STB/CM/1190 issued by Tanishq, Siliguri) from my neck due to which I got scratch mark on my neck and thereafter we went to the Ashghar Out Post and as per the instruction of Duty Officer we left our vehicle there.

Due to this assault all of us got several injury all over our body and their attempt to kill me made us very much frightened thus we could not collect their vehicle number however we could recognized one of them, whose name is Subhamay Roy, father's name not known, resident of Netaji Para, Battala, Fukdebari Bazar, under No.2 Dabgram Gram Panchayat, P.S. Bhaktinagar, Dist. Jalpaiguri (M- 7550875235).

After that we went to the Siliguri Civil Hospital and got treated from there, however the Doctor advised to admit my friend Tubai as his head got severe swelling and to get a CT scan to get the details of any internal injury however we were so frightened that we preferred to go to our house at that time.

In view of the above facts you are, therefore, requested to investigate into the matter and take immediate necessary action against the culprits.
