Sir,

In producing herewith one (01) arrested accused person namely 1) Rajjak Hussain(M/31) S/O Alimuddin, of - Kalughat, PS- Ramganj under Islampur PS, Dist.Uttar Dinajpur (not verified) along with the following seized article under proper seizure as per seizure list;

- a) One transparent plastic packet containing 441.920 grams brown sugar which was kept a black carrybag and marked as "Exhibit- A".
- b) One Multi colour Super Splendar (Hero) showing Registration number WB-92- C/ 8860,
- c) One sky Blue colour Vivo android mobile phone having IMEI no. 866318057539933/33 & 866318057539925/33 which was found kept inside right pocket of Jeans Pant of accused Rajjak Hussain, and marked as "Exhibit- B".
- d) One multi colour Cotton hand bag in which exhibit "A" was kept.

I, SI Biplab Sen, S/O- Kshitish Chandra Sen of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused persons namely Rajjak Hussain to the effect that today on 17.11.2023 at about 18.05 hrs I received a specific source input that one person was standing at PNT Goli near Telephon Exchange, Milanpally under Siliguri PS with huge quantity of Brown Sugar for delivering the same to his designed customers at the adjacent areas. The matter was diarized in Siliguri PS GDE No. 1269, Dt- 17.11.2023 and subsequently, I informed the matter to the Inspector- In-Charge, Siliguri Police Station in written and being directed, myself along with ASI Subir Sen, ASI Debasish Das, CV-283 Prasenjit Dey and CV- 622 Ramanath Barman all of Siliguri PS, SPC along with investigation kit left for PNT Goli near Telephon Exchange, Milanpally, under Siliguri PS by govt. vehicle to verify the veracity of the information. This refers to Siliguri PS GDE No. 1271, Dt- 17.11.2023 and M.C.C No- 273/23 Date- 17.11.2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to PNT Goli near Telephon Exchange, Milanpally, I contacted two persons namely 1) Pradip Some(M/43), S/O- Lt. Sankar Some of Milanpally, near Children Park, Baghajatin Sarani, W/No-25, PS Siliguri, Dist- Darjeeling and 2) Swapan Paul (56), S/O- Lt. Dinabandhu Paul of Mukunda Das Road, Milanpally, w/no- 25, PS- Siliguri, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses noted above reached at PNT Goli near Telephon Exchange, Milanpally, under Siliguri PS at 18:55 hrs and being pointed by my reliable source approached towards one person standing there with a Motor Cycle (Super Splendar). At that time seeing the Police party approaching towards him he started fled away from the spot riding the Motor Cycle but, however we managed to apprehend him with the Motor Cycle. Thereafter, we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he after disclosing his identity as noted above admitted that he has illegally possessed brown sugar for selling the same to his designed customers as per their requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. At this he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, they did not search the police party. Accordingly, I informed the matter to I/C Siliguri PS and as per his kind order, I informed to Shri Gyalsen Lepcha, ACP, East-II, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed Brown Sugar and requested him to come at PNT Goli near Telephon Exchange, Milanpally, under Siliguri PS to remain present and to supervise the search and seizure.

Accordingly at 19.25 hrs Shri Gyalsen Lepcha, ACP, East-II, SPC detailed for acting as Special Executive Magistrate of SPC arrived at the spot at PNT Goli near Telephon Exchange, Milanpally, as Special Executive Magistrate, SPC and in presence of two independent witnesses I searched the detained person following all formalities, keeping his decency and recovered the above noted article from the conscious possession of the accused person namely Rajjak Hussain. Further, on demand in presence of Shri Gyalsen Lepcha, ACP, East-II, SPC detailed for acting as Special Executive Magistrate of SPC the detained person namely Rajjak Hussain failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found 441.920 grams of brown sugar kept in a transparent pouch which was kept a black carrybag and found in a multi colour Cotton hand bag, under the possession of accused Rajjak Hussain and marked as "Exhibit- A". Accordingly, I seized the above noted articles from the conscious possession of accused namely Rajjak Hussain at the spot at PNT Goli near Telephon Exchange, Milanpally under proper seizure list in presence of independent witnesses and Shri Gyalsen Lepcha, ACP, East-II, SPC detailed for acting as Special Executive Magistrate, SPC obtaining his signature and being acknowledged by the accused person. Subsequently, I labeled and sealed the seized articles in presence of Shri Gyalsen Lepcha, ACP, East-II, SPC, detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused person. The whole process of seizure was made in between 19.35 hrs to 20.20 hrs.

Being further asked, the apprehend person namely Rajjak Hussain admitted in presence of Shri Gyalsen Lepcha, ACP, East-II, SPC detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that he have procured the brown sugar clandestinely from Malda for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. He also disclosed that he have been dealing in this business of procuring and selling of brown sugar illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Rajjak Hussain is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Rajjak Hussain after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Rajjak Hussain(M/31) S/O Alimuddin, of - Kalughat, PS-Ramganj under Islampur PS, Dist.Uttar Dinajpur (not verified) and arrange for its investigation.
