Sir

In producing herewith 03 (three) arrested accused persons namely (i) Ujjwal Chhetri (32 yrs) S/O Uday Chhetri of Thakurigaon, Pokhrebong, PS- Sukhiapokhri, Dist.- Darjeeling (ii) Shiva Chhetri (21 yrs) S/O Late Suresh Chhetri of Sourini Bazar, PS- Mirik, Dist.- Darjeeling and (iii) Arbin Pradhan (30 yrs) S/O Gobin Pradhan of Starling, Ghoom, PS- Jorebanglow, Dist.- Darjeeling along with following seized articles viz :-

- 1) One iron made weapon called as Bhojali seized from the exclusive and conscious possession of accused Ujjwal Chhetri S/O Uday Chhetri of Thakurigaon, Pokhrebong, PS- Sukhiapokhri, Dist.- Darjeeling
- 2) One steel made sharp cutting knife measuring approx 8" in length seized from the exclusive and conscious possession of accused Shiva Chhetri (21 yrs) S/O Late Suresh Chhetri of Sourini Bazar, PS- Mirik, Dist.- Darjeeling.
- 3) One iron made weapon called as Bhojali seized from the exclusive and conscious possession of accused Arbin Pradhan (30 yrs) S/O Gobin Pradhan of Starling, Ghoom, PS- Jorebanglow, Dist.- Darjeeling.

I, SI Goutam Mallik of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 03 (three) arrested accused persons namely (i) Ujjwal Chhetri (32 yrs) S/O Uday Chhetri of Thakurigaon, Pokhrebong, PS- Sukhiapokhri, Dist.- Darjeeling (ii) Shiva Chhetri (21 yrs) S/O Late Suresh Chhetri of Sourini Bazar, PS- Mirik, Dist.- Darjeeling and (iii) Arbin Pradhan (30 yrs) S/O Gobin Pradhan of Starling, Ghoom, PS- Jorebanglow, Dist.- Darjeeling and 09/10 others to the effect that today on 19.11.2023 at 00.15 hrs received a specific source information that 12/13 miscreants have assembled in a dark place beside SNT Bus Stand under PS- Pradhan Nagar, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Pradhan Nagar area. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarized the fact in General Diary vide Pradhan Nagar PS GDE No 996 Dated 19.11.23 and as per order I along with ASI Manoj Kr Das, C/762 Majibul Rahaman, CV/992 Jagadish Biswas, CV/646 Baban Das, CV/242 Rakesh Monger, CV/645 Pankaj Gupta and CV/128 Ajoy Kr Sahani all of Pradhan Nagar PS, SPC, left for SNT Bus Stand under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information in hand. I also contact with night RT van officer SI Bijoy Sarkar and ASI Sanjit Mandal both of Pradhan Nagar and directed them to come at near SNT Bus Stand. At about 00.35 hrs we arrived at near SNT Bus Stand and the above noted RT van officer also arrived there and accompany with us. Then, I contacted with my source and as indicated by the source we noticed that 12/13 persons assembled in a dark place beside SNT Bus Stand and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 03 (three) of them with deadly weapons in their possession but 09/10 persons managed to fled away from the spot taking the advantage of darkness. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they along with their associates were assembled there and making preparation for committing dacoity in a house of Pradhan Nagar area. On search the above noted weapon of offence recovered from their possession.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest and brought them to Pradhan Nagar PS. The search seizure and arrest made in between 01.05 hrs to 01.45 hrs on 19.11.2023.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons namely (i) Ujjwal Chhetri (32 yrs) S/O Uday Chhetri of Thakurigaon, Pokhrebong, PS- Sukhiapokhri, Dist.- Darjeeling (ii) Shiva Chhetri (21 yrs) S/O Late Suresh Chhetri of Sourini Bazar, PS- Mirik, Dist.- Darjeeling and (iii) Arbin Pradhan (30 yrs) S/O Gobin Pradhan of Starling, Ghoom, PS- Jorebanglow, Dist.- Darjeeling and others 09/10 unknown persons and arrange for its investigation.
