Kamrul want to Malati khatoon land which was situated at Adarsha Nagar for paying consideration amount to maltikhatoon as it was previously decided that Maltikhatoon sold her 1.5 khata land for Rs:-450000/- and my sister will buy such piece of land and for that reason the current owner of the land received one lakh rupees for her treatment from my sister as a baynanama. But suddenly the above mentioned accused persons came with dare consequences and told that except them no one can buy this land and when my sister try convince them and told them that she already paid one lakh rupees as baynanama and the land owner also sale such land to her but they did not paid any hid beside that they using filthy languages and started beaten my sister and then they snatched her cloth and a gold chain which was on her neck they also took that and as a result my sister fall down and sustain serious injuries on her body.

Then with the help of some local people I some how try to rescue her and took her to the Siliguri district hospital and after doctor consultation she got admitted to the hospital.

I also mentioned here that the land owner give the consent of sale such land to my sister Marzina Khatoon.

Therefore I request you please look into this matter as soon as possible and take proper legal action on it.
