Even the father has threatened use of contacts and monetary adjustments to keep his son away from legal process.

Infact these discussions are spreading like fire in all the relatives which is making my life more difficult due to which I am even unable to go

to my workplace. Even my mother is disturbed and I am a single parent, <sup>child</sup> which is making my life more stressful.
