I, SI Uday Chakraborty of Bagdogra PS do hereby producing the arrested accused person namely Jugal Das (58) S/o Lt Joydeb Das of Hansqua PS Bagdogra Dist. Darjeeling along with the following seized Fire crackers under proper seizure list viz;

- 1) 52 (fifty two) Packets of Burimar's chocolate Crackers (Big) containing 12 pcs each, mfg by B.M. Fire Works.
- 2) 64 (Sixty four) Packets of Cobra Electric Crackers containing 28 pcs each, mfg by Sri Vijay Pysotechnic factory, Sivakasi.
- 3) 15 (Fifteen) Packets of RHINO Power Chocolate (original) containing 10 pcs each, mfg by S.S. Enterprises, Kolkata.
- 4) 06 (Six) packets of Jugmug Chocolate Junior Fire Crackers containing 12 pcs each.

I SI Uday Chakraborty of Bagdogra PS, SPC do hereby lodged a written complaint against the above noted accused person to the effect that today on 18.11.23 at 18-35 hrs received a source information that one person have been storing and selling Fire-crackers from his shop styled as Radha Krishna Bhandar situated at Hansqua More PS Bagdogra without having any license or other valid documents violating the provision of law which may endanger human life and likely to cause injury, accordingly I share the information to the duty officer and also O.C. Bagdogra PS which noted in GD vide Bagdogra PS GDE No. 829 dtd. 18.11.23 and as per direction of O.C. PS myself alongwith, SI Binup Mahato, VP-01 Ansalam Kujur , CV-375 Jogesh Barman CV-386 Kishor Hawlder, left for the spot to verify the veracity of the information vide Bagdogra PS GDE No. 830 dt. 18.11.23. On arrival At 18-55 hrs at Hansqua More PS Bagdogra on being identified by the source we held raid in the shop of above noted accused person named as Hare Krishna Bhander in presence of disinterested witnesses namely (1) Akash Nagasia (31) s/o·Lt. jiten Nagasia of Gangaram Tea Garden PS- Bagdogra Dist. Darjeeling and (2) Goutam Barraik (46) S/o Lt. Mahabir Barraik of Hansqua PS- Bagdogra, Darjeeling and apprehended one person from the shop i.e. Hare Krishna Bhander who disclosed that he is owner of the said shop and also disclosed his name and address mentioned above. Thereafter on being searched I recovered above noted firecrackers from his possession from his said Shop. On demand the apprehended person failed to produce any valid documents/licenses in support of the possession of such quantity of Fire Crackers. There is a reason to believe that the said person was storing and selling fire crackers which are combustible in nature and endanger to human life and property. The Fire crackers were stored in his house without any precautionary and safety measure, Accordingly, I seized the fire crackers under proper seizure list duly signed by the witnesses and also the accused person. Accordingly, I arrested the above noted accused person and issued memo of arrest on the spot duly sign by him. The seizure & arrest was made in between 19-05 hrs and 20-05 hrs (Total weight approx 7.600 Kg).

Under the above circumstances I pray before you that a specific case may kindly be started against the above accused persons namely Jugal Das (58) S/o Lt Joydeb Das of Hansqua PS Bagdogra Dist. Darjeeling under proper section of Law, to arrange for its investigation.
