Dear Madam,

With due respect I the undersigned would like to inform you that, I have been married with Sri Bibhash Dhar, S/o. Sri Prasanta Kumar Dhar of Dhar Vila, Rabin Sen Colony, Tumba Jote, Near Juvenile School, P.O & P.S Matigara Dist. Darjeeling and said marriage was solemnized on 01/02/2021 according to Hindu Rites & Customs at Kiran Chandra Bhawan (Banga Bhawan), Sevoke Road, Siliguri. At the time of solemnization of the said marriage as per the demand of my husband and my in laws, my father and other near relatives have paid a sum of Rs. 5,00,000/- in cash, alongwith gold ornaments, utensils, household articles etc.

I would like to further inform you that the said marriage was registered before the Marriage Registrar Sri Bijoy Kumar Ghosh on 02/02/2021 in the place of the said bhawan. On 02/02/2021 I was brought by my husband in my matrimonial house at Matigara alongwith those valuable articles and I have entrusted all those valuable articles and goods to my husband and mother in law namely Smt. Tapati Dhar and as per the request of my husband and father in law Sri Prashanta Kumar Dhar I have entrusted the valuable gold ornaments to my father in law and he convinced me that same will be kept in his locker in the bank for its safety & security.

I would like to further inform you that, after elapsing of few months on and from the date of the said marriage my in laws have started to regret by expressing that their son i.e. my husband is a government employee and they can get a handsome dowry including more cash amount if they would give the marriage of their son elsewhere and they also started to make bad remark towards me regarding my morality and they used to say that I have caught their son with false love and affection before the marriage and inspite of those illegal activities of my in laws I have swallow the same with a hope for a better conjugal life.

I would like to further inform you that, due to the continuous nagging and abusing those illegal and irrelevant remarks, I suffered from mental agony and I was compelled to inform the matter to my husband but it was very

surprised to me that I found my husband is also sailing on the same boat. My husband told me that I am the only daughter and also told me to ask my father to give him a four wheeler as he can use it for his smooth private transportation in his service place at Haldibari Naba Kishore High School. But I tried to convince him that although I am the only daughter but my father is not financial able to meet up the said demand. My husband and in-laws have started to quarrel with me frequently on the issue of the demand of dowry and gradually same was converted to the physical abuse by my husband with the instigation of my in-laws whenever I refused to fulfill their demand through my father. Gradually said mental and physical torture has become intolerable and I was compelled to inform the matter to my father and my father has agreed to fulfill their part demand by giving the valuable furnitures with an undertaking and promise to fulfill the demand of vehicle within one year for purchasing the peace in my conjugal life just to see me happy and the smile in my face and as per the choice of my husband regarding the brand (Damro), my father has given the furniture i.e. wooden khat, dressing table, almirah, shoe rack and one side table. And those furniture were delivered in my matrimonial house in the month of August, 2021.

I would like to further inform you that, after receiving those furniture my husband and my in-laws were silent for a moment but they have again started their such demand of dowry in the same fashion but I tried my level best to keep happy to my husband and in-laws and I tried to discharge my all matrimonial obligation and duties in my matrimonial house with a hope for a better conjugal life. In the month of December, 2022 I conceived and in my advance stage of said pregnancy, I found that my husband and in-laws have started to neglect me regarding my health issues and my baby in the womb including my proper nutrient and they also refused to take me to the physician for the routine check-up and ultimately for the safety of my baby in the womb, I requested my father to bring me in my paternal place and in the month of June, 2023 I started to live with my parents under their care and I gave birth of a female child on 17/07/2023. After the birth of the said new born baby a fresh air came into my life and I thought the said new born baby will built a bridge for keeping my husband and my in-laws close to me but I found that my husband and in-laws were not happy at all and they met the very nasty comment that I am not able to give birth of a male child and getting that view of my husband and in-laws I was seriously dis-hearted but I tried my level best to nourish my new born baby with a utmost effort with the physical and mental support of my old parents and my husband has measureable failed to


discharge his duty even also did not pay any single furthering to me for the maintenance of said new born baby.

I would like to further inform you that on several occasions my husband threatened me and my father with dire consequences for not fulfilling his demand of four wheeler and on 11/11/2023 my husband and his father came to my paternal place and started to pressure upon me to put some signatures in some documents which he brought with him and on refusal he assaulted me and he tried to throw out my minor daughter by snatching her from my lap and seeing the said audacity, my father tried to resist him but he became very violent and forcibly kicked on his lower abdomen and he also pushed my mother and for that my father sustained injury in his abdomen and my mother became faint and due to the tremendous torture and pressure I was compelled to put my signature in those documents and they also obtained the signature of my parents therein without knowing the contents of those documents and we put our respective signatures only to save my minor daughter and after the said unexpected incident I alongwith my parents became seriously ill mentally and physically.

I would like to further inform you that I have been tortured by my husband and in-laws and I have no other alternative but to lodge this complaint and you are requested to investigate the matter for the ends of justice.


