I, SRI BIJAI GHOSE, son of Late Keshab Chandra Ghosh, residing at Harisava Road, New Milanpally, within Ward No. 25 of Siliguri Municipal Corporation, Post Office - Siliguri Bazar, Police Station - Siliguri, Pin - 734 005, District - Darjeeling,, would like to inform you that I alongwith my 2 (two) brothers, (1) SRI SURYA GHOSH @ SURJYA KANTA GHOSH and (2) SRI BOJOY GHOSH @ BRAJEN GHOSH have jointly acquired altogether land measuring about 9 (nine) kathas in L. R. Plot No. 5, recorded in L. R. Khatian No. 402, 403 & 404, situated within Mouza - Thiknikata, J. L. No.74, Touzi No. 8, Pargana - Patharghata, Police Station - Matigara, District - Darjeeling, by virtue of 3 (three) separate Deed of Sale, being Nos. I-8350 of 2011, I-3476 of 1992 and I-8383 of 1992 and the total land is under one boundary with Iron Gate and 2 (two) shop rooms on the front side of the land.

Sir, recently I got information from reliable sources that one SAMIR KUMAR BASSU, son of Late Surendra Nath Basu of Ganga Nagar, Paschimpara, District - Nadia is trying to grab our aforesaid land on the strength of a false/ fake Deed of Conveyance, being No. I-1950 of 2022. It is to be mentioned here that on 29.10.2022 one DHANANJOY ROY having Cell Phone No. 81014-74176 and his associates tried to enter into our aforesaid land by breaking lock of the gate but due to our active interference and resistance they could not be succeeded. At this, I lodged a complaint with the NBMC Hospital Out Post Police Station the same date.

Sir, the above named SAMIR KUMAR BASU, DHANANJOY ROY & their associates may enter into our land by breaking the lock of the gate and take physical possession of the land and shop rooms at any moment illegally and unlawfully by taking law in their own hands.

Your good office is therefore requested to look into the matter and do the needful and also take appropriate action against the above named persons together with their associates those who are trying to enter into our landed property and also trying to occupy the same for their illegal and unlawful gain and save us and our property from such illegal activities.
