Written Complaint for Non-Payment, Misappropriation and Cheating

Sir,

I. Smt. Nabamita Paul, W/o- Gautam Kumar Paul, residing at Ruma Bhawan, Devi Choudhurani Road, Samadhan Kendra, Salugara, P.O- Salugara & P.S- Bhaktinagar, Dist- Jalpaiguri want to lodge this written complaint against the Somnath Mukherjee, S/o Lt. Biswanath Mukherjee, resident of Greenook Apartment, Flat no. 2AR2, Purbanchal Kalitala Road, Garfa, Kolkata, Pin- 700078.

I am the Owner of a Mahindra TUV300 with the Registration no- WB74AJ3572. On 05.04.2023, the accused person entered into an agreement with me to lease the aforementioned vehicle. Thereafter he takes the delivery of the vehicle from my residence and told me that the said vehicle is plying only surrounding the city of Siliguri. According to our agreement, he has to pay a monthly sum of Rs. 20,000 for the lease. On 10.05.2023, the accused person made an initial payment of Rs. 19,000 through the bank. However, he has since ceased making the monthly payments, despite repeated demands and requests from my end.

Despite my efforts, including sending a legal notice, the accused person has neglected to settle the outstanding monthly dues and has not returned the leased vehicle. Furthermore, he has failed to provide information regarding the current location and usage of the vehicle, and he is unresponsive to my phone calls and messages.



Based on the above circumstances, it is evident that the accused person is intentionally misappropriating my property for personal use and has potentially sold the vehicle. I believe I have been cheated, as he has neither fulfilled the agreed-upon monthly payments nor returned the vehicle.

I kindly request that you take strict legal action against the accused person to facilitate the recovery of the leased vehicle and the outstanding monthly rental dues. I trust that the authorities will conduct a thorough investigation into this matter and take the necessary steps to ensure justice is served.
