Respected Sir,

I, **MINA SAHA**, W/O Niren Saha, Resident of 45/8 Baghajatin Colony, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, I do here by want to inform you as follows :-

1. That I am the law abiding Senior citizen of India, and a permanent resident of aforesaid address.
2. That I reside along with my family members my husband namely Niren Saha, (Age about 74 years), my son namely Krishnendu Saha and his wife and children at the aforesaid address.
3. That my husband owns grocery shop running under the name and style as "N.S .SHOP", at the above mentioned address.
4. That on 20.11.2023 at about 9:30 pm when my husband was at the said grocery shop suddenly without any relam or reason one person namely Debabrata Mukherjee, S/O Late Dipak Mukherjee, residing at 45/9 Baghajatin Colony, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, came in front of the shop and started to abuse my husband and my son with filthy languages and when my husband who is a chronic Heart Patient protested the same, the said Debabrata Mukherjee, S/O Late Dipak Mukherjee attack my husband's shop and started to vandalise the said shop by destroying all the items.
5. That thereafter when my husband tried to protest upon the said illegal acts, the said person started to beat my husband mercilessly and hit him on his leg, at this my husband fell down and when I came to rescues my husband the said Debabrata Mukherjee, S/O Late Dipak Mukherjee forcefully pushed me on the floor.
6. That at that time my son came to the spot and tried to rescues me and my husband from the attack of the said Debabrata Mukherjee, S/O Late Dipak Mukherjee then the said Debabrata Mukherjee, S/O Late Dipak Mukherjee attack my son and started to beat him mercilessly with fist and blows and this my son got injured.
7. That during this incident the said Debabrata Mukherjee, S/O Late Dipak Mukherjee suddenly fell down in the drain and started to give allegation to my son that he has pushed the said person.

8. That after that the wife of the said Debabrata Mukherjee, S/O Late Dipak Mukherjee namely Sushmita Mukherjee came and started to abuse me, my husband and my son with filthy languages and demanded money from my son and husband who was then injured.
9. That the said Debabrata Mukherjee, S/O Late Dipak Mukherjee and his wife demanded Rs. 40,000/- from us as an extortion money otherwise they threatened us that they will implicate us in false cases and will shutdown our shop
10. That subsequently my husband and my son were taken to Siliguri District Hospital for our severe injuries.
11. That the above named accused persons always used to throw filthy and slang words upon us and whenever we tried to protest the same they used to threat us that they can do anything with us and if we dare to take any legal action against them they will kill us.
12. That thereafter the above named persons are very much desperate and started to threatened us that they will take revenge from us by killing all my family members.
13. That still that accused person as they are too much desperate in nature did not allow us to stay in my house peacefully and as a result we have to spent our days as bewildered condition and the life and dignity and honour of us are in danger and we are passing our days with great fear/tension/anxiety for the continuous threat given by above named accused persons.
14. That I am a helpless person and seeking justice from you by taking necessary legal action against the accused culprits, namely **DEBABRATA MUKHERJEE**, S/O Late Dipak Mukherjee, **SUSHMITA MUKHERJEE**, W/O Debabrata Mukherjee , resident of 45/9, Baghajatin Colony, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, and take the necessary legal steps as our life are in very much danger and the above named accused persons can any time attack us.
