in complete drunk condition and was using vulgar and
slang languages towards me and when I told him not to do
the same he became furious and started pushing me
and hitting me seeing all this 5 more persons

Ajay Mahato s/o DO, R/o DO, Santosh Yadav s/o not
known R/o Panighatta Road Near Jagriti Club P.S BDR,
Sunil Paswan s/o not known R/o Hochimin Nagar Lichi Bagan
P.S BDR, Anil Mallik s/o Bindukul Mallik R/o

Bagdogra Hospital Quater P.S Bagdogra came and
mercilessly and brutally started assaulting me with
Iron Rods, Iron Knuckle punches, and with boulders

hit me on the vital body parts my face got severely
injured as they have hit me with iron knuckle
and boulders over my face, head and chest and
also hit me with a iron rod over my waist
