Subject: Complaint against Mr. Sanjay Sarkar and others for fraud, assault, and threats

Sir/Madam,

I, Dilip Kumar Das, S/O Late Sudhir Chandra Das, residing at Opposite Vishal Cinema, 2nd Mile, Sevoke Road, Siliguri 734001, would like to bring to your attention a serious matter of **fraud, assault, and threats** that I have been subjected to by Mr. Sanjay Sarkar, S/O of Late Narayan Sarkar, and his associates from Sarkar Jewellers and Sarkar Garage, Ashikghaat More, Siliguri.

On the 28th of June 2005, I paid Mr. Sanjay Sarkar a sum of **Rs. 8,50,000** (Eight Lacs Fifty Thousand) in cash for the purchase of a 1 Acre & 50 decimals of land at Farabari Anchal. I possess all necessary documentation and proofs of this payment. However, despite receiving the money, Mr. Sanjay Sarkar and his associates have not provided me with the promised land, and they have also resorted to violence and threats.

Not only did they fail to deliver the land, but they also entered my shop premises on Sevoke Road, accompanied by 4-5 individuals, and physically assaulted me with belts. To make matters worse, they have been consistently harassing me by making threatening phone calls (**Phone Number of MR. Sanjay Sarkar 9832062986**) to my personal number, using abusive language and making severe threats against my life and well-being.

I am left in a state of helplessness as I am currently unemployed and have exhausted my financial resources. This incident has taken a severe toll on my physical and mental health, and I am deeply concerned for my safety. At the age of 65, I am a senior citizen and am seeking your assistance to ensure that justice is served.

I kindly request you to take immediate and strict action against Mr. Sanjay Sarkar and his associates, and I urge you to recover my hard-earned money along with the due interest as of today. This money represents my life's savings, and I am left with no means to pursue any legal action against the culprits.

I have attached all the relevant documents and proofs related to the cash payment and the incident that occurred. I trust that the police department will act swiftly to bring the culprits to justice and provide me with the protection and assistance I require.

I humbly seek your intervention and appreciate your prompt response to this matter. Please let me know if you require any further information or assistance from my end.
