I beg to say that I Bapi Gupta S/o Sri Ganesha Prasad Gupta of Mahananda Para ward No 6 would like to inform you that I had filed a partition suit No 45/2019 in 1d Civil Court Siliguri and due to the intervention of my relatives friends. I withdrew the case on feb 2023 with an assurance of my share of three shop

But sorry to inform you sir after the withdrawal of the case the other share holders started obstructing me from developing and renting my share and threatening me I then on 07.09.2023 with a written complain approached Khalpara out Post by my complain was not received and instead told me they will see to the matter.

But sir again on 24 Nov 23 the situation became worst when Sri Sanhar Prasad, Renu Gupta. Smt Sandhya Devi and her son Subham Prasad came to me and abused me and brutally hit me passing on the floor with kicks and bamboos on my chest, head and shoulder and Subham Prasad warned to harm again and kill me if I don't change my decision as he have no fear as he stays abroad.

The Peoples and my brother resquied me and took me to the hospital, Sir I couldn't report yesterday as I was injured on brain chest, I couldn't stand properly and was on bed.

Sir I pray to take necessary action regarding the matter.
