
Sub: SUSPECTED IMPERSONATION/FRAUD CASE : FIR THEREOF

3rd phase examination of CT(TM) -2023 underway at 176 Bn BSF Camp, Kadamtala has detected a suspected impersonation case in which one person namely MD Raquib (Roll No. 0705019988) S/O MD Monam R/O Vill- Sujawalpur, PS-Muffasil, Distt-Munger, State-Bihar – 811202 (Phone No. 7549820569) has appeared before the recruitment board on 23.11.2023 but during the Bio-Metric verification carried out by Tata Consultancy, his finger print and photograph did not match with SSC recorded biometric data of Roll No. 0705019988. During primary enquiry it was found a suspected case of forgery and impersonation. Further, MD Raquib (Roll No. 0705019988) filled a form meant to be filled by suspected persons, in which candidate certified / accepted that he has not attended the written examination of CT(Cook)-2023 but another person has attended on his behalf who had taken Rs. 30,000/- from him. In this regard, individual written application (original) and photocopy of suspected form (filled by individual) attached with this letter for FIR.

2. It is therefore, requested that FIR may be lodged under sections 419, 420, 465 of IPC & Section 34 of the Aadhaar (Targeted Delivery of Financial & Other Subsidies, Benefits & Services) Act 2016 or any other sections of applicable laws and further necessary action may be taken against the above mentioned suspected person.
