Sir,

In producing herewith one (01) arrested accused person namely Karan Oraon (18) of Goursinghote near SSB camp PS Kharibari Dist. Darjeeling along with following seized articles viz,

1. One transparent zipper plastic packet containing brown sugar weighing 259 (Two hundred and fifty nine) grams approx wrapped with red colour handkerchief , Marked as Exhibit- A.
2. One transparent zipper plastic packet containing 10 grams brown sugar which was taken from Exhibit-A for examination as a sample and marked as Exhibit-A1.
3. One Blue & Purple colour Techno Spark Android Mobile phone having IMEI No-(i) 355935280599828 (ii) 355935280599836 marked as Exhibit-C

I, SI Uday Chakraborty of Bagdogra Ps , Siliguri Police Commissionerate do here by lodged this complaint against the above noted accused person to the effect that on 27.11.23 at about 12.35 hrs I received a secret source of information that one person was standing in front of Army Track Marshal under Bagdogra PS beside NH-31 road with huge quantity of brown sugar for clandestinely disposal of the same illegally. Accordingly I informed the matter to the duty officer and O.C PS which was diarized vide Bagdogra PS GDE No- 1235 dt- 27.11.23. Thereafter as per his instruction myself along with SI Binup Mahato, SI Debabrata Khan, ASI Amit Lama ,C/875- Seshnath Jha, VP- 02 Pradip Roy, CV-389 Janak Singha left for the spot to verify the veracity of the information vide corresponding Bagdogra PS G.D.E. No. 1236 dtd 27.11.23 and Bagdogra PS M.C.C No- 774/23 Dt.27.11.23.

At the time of departure from the Police Station I bring a spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal, emergency light etc. On arrival at about 13.05 hrs beside NH-31 in front of Army Track Marshal, Bhujipani under Bagdogra PS by Govt. vehicle bearing No. WB-68-Q-6401, we found one person standing there in a suspicious manner and on being identified by the source we tried to apprehend him but seeing the police team the accused person tried to flee away from there and on hot chase we somehow managed to detain him. In the mean time near the said place I called two independent witnesses namely (1) Gaya Basfore (39) S/O Lt. Matowala Basfore of Tiger Busty, Suryanagar, PS-Bagdogra Dist. Darjeeling and (2) Sandeep Thapa (44) S/O-Late Bal Bahadur Thapa of Tiger Busty, Suryanagar, PS-Bagdogra Dist. Darjeeling and informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. On being asked he disclosed his name and identity as noted above which is not verified as on spot he could not produce any documents in support of his identity. After disclosing our identity I asked him whether he wanted to be searched himself in presence of an Executive Magistrate or any Gazetted Officer as we have information the apprehended person was carrying huge quantities of drugs like brown sugar and he agreed to search by any one. I also served him an option of notice in accordance with the provisions of law in this regard in writing and he also gave his approval of being searched by any one in writing in the notice served to him. Accordingly I informed the matter to O.C. Bagdogra PS and he informed me over mobile phone to send one requisition to Sri Pasang Topgay Bhutia, ACP, (Traffic East), SPC as he detailed for special executive magistrate for this date as no other magistrate were available in that time. Accordingly I informed Sri Pasang Topgay Bhutia, ACP, (Traffic East), SPC and requested him to come to the spot through one special messenger namely C/875 Seshnath Jha at his office at Mallagur, Siliguri. At about 14.35 hrs Sri Pasang Topgay Bhutia, ACP, (Traffic East), SPC and O.C. Bagdogra PS arrived at the spot and I disclosed the identity of Sri Pasang Topgay Bhutia, ACP, (Traffic East), SPC as a Gazetted officer to the accused person and also to the witnesses. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But they

refused to search the police party. Under the supervision of Sri Pasang Topgay Bhutia, ACP, (Traffic East), SPC and in presence of independent witnesses I conducted searched and recovered one thin zipper plastic packet in contents said to be brown sugar wrapped with red colour handkerchief which he was carrying in right side pocket of his pant . On demand in presence of the Gazetted Officer Sri Pasang Topgay Bhutia, ACP, (Traffic East), SPC the apprehended person failed to produce any valid documents in support of possessing the same.

I accordingly weighed the recovered said to be brown sugar (Heroin) by the weighing instrument and seized (i) One transparent zipper plastic packet containing brown sugar weighing 259 (Two hundred and fifty nine) grams approx wrapped with red colour handkerchief , Marked as Exhibit- A (ii) One transparent zipper plastic packet containing 10 grams Brown Sugar which taken from Exhibit-A for examination as sample and marked as Exhibit-A1 and (iii) One Blue & Purple colour Techno Spark Android Mobile phone having IMEI No-(i) 355935280599828 (ii) 355935280599836 marked as Exhibit-C from the exclusive possession of the apprehended person under proper seizure list and labeled and sealed all the articles in presence of Sri Pasang Topgay Bhutia, ACP, (Traffic East), SPC and independent witnesses and accused person, duly signed by them and the Gazetted officer Sri Pasang Topgay Bhutia, ACP, (Traffic East), SPC and acknowledged by the accused person. On further asked the apprehend person confessed his guilt in presence of Gazetted Officer Sri Pasang Topgay Bhutia, ACP, (Traffic East), SPC and other witnesses that he procured the said brown sugar clandestinely from Khoribari for the purpose of selling the same to his designated customers in order to earn huge money illegally. Then I arrested the above noted accused person u/s- 41 CrPC after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest .The copy of seizure list and Memo of Arrest has been supplied to above noted accused person under proper receipt as the accused person violated the terms and condition of NDPS Act. The seizure was made between 14-45 hrs to 15-55 hrs.


Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused person namely Karan Oraon (18) S/O-Chillu Oraon of Goursinghote near SSB camp PS Kharibari Dist. Darjeeling and arrange for its investigation.
