At around 2 P.M, my son namey Avitaj Kumar Sharma  
aged about 3 years was brutally beaten by Anu Sharma  
aged about ~~15~~ years. AS, my son returned home seeing  
his condition I was shocked and gave first Aid. and later  
took him hospital.  
AS I went to the house of Anil meet Parents of Anu Sharma  
at around 4 P.M.  
my neighbours, they were in the road in front of gate  
AS, I stated them they started abusing me in filthy languages  
in Public and pulled by clothes, outraged my modesty  
in front of many Peoples. Anil Sharma and his wife  
tried to take me inside the gate. of their house.  
In the meantime my gold chain was snatched and  
I was helpless, instead of counselling about the  
situation they ended up beating me and made me helpless  
in Public.

Later, few people came as I shouted for help and  
they saved me from them. Also, they warned me  
that they will not let me live there in Peace if  
they want they will not hesitate to attack my  
family.

Kindly take the proper action and help us by serving  
Justice.
