Respected Sir,


I, Smt. Madhuri Devi, Wife of Sri Anil Sharma, resident of Shastri Nagar, beside Kalimandir within Ward No.41 of S.M.C., P.S. Bhaktinagar, Dist. Jalpaiguri, beg to state you that yesterday i.e. on 26.11.2023 at about 1:30 p.m. one minor boy viz. Abhiranjan Sharma, Son of Santosh Mistri hit my son Annu Sharma and during their quarrels the parents of Abhiranjan Sharma namely Smt. Rina Devi, Wife of Santosh Mistri and Santosh Mistri, Son of Sri Domi Mistri came to the spot and started to beat my minor child and when I tried to resist them they shoutdely called their relatives namely Sambhu Sharma, Son of Sri Domi Mistri, Smt. Rubi Sharma, Wife of Sambhu Sharma, Abhijit Sharma @ Kanahiya, Son of Santosh Mistri, Smt. Aalti Devi, W/o Sito Das, Pintu Sharma @ Rahul, Son of Sito Das surrounded me at the spot and started to beat me by fists and blows then and there. I cried and screamed for help to rescue myself from the evil clutches of the aforesaid persons but they continuously beaten me and also torn my clothes in front of the locality and also injured me badly. Seeing my such condition some people come here to rescue me and those people viz. Smt. Rina Devi, Santosh Mistri, Sambhu Sharma, Smt. Rubi Sharma, Abhijit Sharma @ Kanahiya, Aalti Devi & Pintu Sharma @ Rahul fled away from the spot. During such violent act conducted by these persons against me amongst the above named persons someone snatched my gold chain from my neck.

Sir, I therefore requesting you to take drastic legal actions against said (1) Smt. Rina Devi, (2) Santosh Mistri, (3) Sambhu Sharma, (4) Smt. Rubi Sharma, (5) Abhijit Sharma @ Kanahiya, (6) Aalti Devi & (7) Pintu Sharma @ Rahul in accordance with law and your good cooperation is very much expected in this regard.
