
I, SI Goutam Mallik of Pradhan Police Station, SPC would like to lodge this written complaint against one accused named Sumitra Paswan W/O Chandeswar Paswan of Rajendra Nagar Coolipara near Samsan Ghat, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that today on 28.11.23 at 11.45 hrs I received a secret source information that one lady has been selling and procuring illegal liquor at her residence at Rajendra Nagar, Coolipara, PS- Pradhan Nagar, Dist.- Darjeeling without any valid license. Accordingly, I informed the matter to the I/C PradhanNagar PS and diarized the fact in General Diary vide Pradhan Nagar PS GDE No 1194, dated 28.11.23 and as per his kind order and direction myself along with SI Youel Lepcha, ASI Biplab Kr Das, LC/1269 Pramila Chhetri, CV/646 Baban Das and CV/242 Rakesh Mangar all of Pradhan Nagar PS had been to Rajendra Nagar, Coolipara under PS- Pradhan Nagar, Dist.- Darjeeling to verify the veracity of source information. After arrival at Rajendra Nagar Coolipara, I contacted with my source and as indentified by the source conducted raid at the respective residence but seeing the police party the owner of the residence named Sumitra Paswan managed to fled away from the residence. Further being searched total 17 (seventeen) bottles of KINGFISHER STRONG BEER, each bottle contain 650 ml, (Total 11,050 Liters) recovered from the said residence which was kept in a nylon bag. Held local enquiry at it is learnt that one lady named Sumitra Paswan W/O Chandeswar Paswan of Rajendra Nagar Coolipara near Samsan Ghat, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling is involved in selling and possessing of liquor without any valid license since long for her illegal gain. Accordingly, I seized and labeled the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and marked as Exhibit "A" out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "A1". The whole process of seizure and label has been made in between 12.55 hrs to 13.45 hrs at the spot.

I, therefore pray before your good self that a specific case may kindly be initiated against Sumitra Paswan W/O Chandeswar Paswan of Rajendra Nagar Coolipara near Samsan Ghat, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
