Subject: Urgent Complaint of Physical Assault, Harassment, and Threats by Son and Daughter-in-law

Dear Sir,

I, Pravin Mukhia, Son of Late Harish Mukhia, residing at Riverdale, Shankar Busty, Near Gramin Bank, P.O. Salbari, P.S. Pradhannagar, Dist. Darjeeling, am writing to lodge a formal complaint against my son, Nihar Mukhia, and his wife, Cheten Tashi, for subjecting me to ongoing mistreatment and, most recently, a physical assault and a mental torture on dated 3/11/23.

For an extended period, I have endured the consistent torment caused by the alcohol and drug dependency of my son and daughter-in-law. However, the situation escalated on 3/11/23 when they not only physically assaulted me but also forcibly expelled me from my own home. As a senior citizen in dire need of care and currently experiencing various ailments, I find myself in a distressing and vulnerable state.

While I have harbored a soft spot and affection for my son and daughter-in-law, I can no longer tolerate their abusive behavior. Despite having gifted them a flat in Uttorayon, Matigara, they have failed to maintain it, consequently rendering it unsuitable for their residence. Due to this, they have been staying with me for a few months, during which their daily intoxicated state has resulted in continuous mental and physical harassment towards me.

Their threats of dire consequences if I attempt to re-enter my own home have left me without a place of refuge during my elderly years.

I implore your immediate intervention and action against Nihar Mukhia and Cheten Tashi. I seek your assistance in reinstating me in my residence and ensuring my safety and well-being in these trying times.

I earnestly request your prompt attention and resolution to this urgent matter.
