1. That I am the absolute and registered owner of the land measuring 2 Katha & 8 Chatak vide registered Sale Deed Being No - I - 6280/2016 A.D.S.R Siliguri II Being Khatian No - 3963, Mouza- Kalabari, J.L. No.- 45, Police Station- Pradhan Nagar, Touzi No- 8(91), Plot No- 115(R.S), 268(L.R), .below named person have threatened me and illegally entered into my land by using force .
2. That I have lodged a written complaint on dated 5th March 2022 at Pradhan Nagar P.S ,against 1. Smt. Bihani Oraon, wife of late Etwa Oraon, 2. Sri. Sunil Oraon, 3. Sri Rajib Oraon no. 2 and no 3 are sons of late Etwa Oraon, 4. Sri. Ajay Jha, 5. Sri. Ajay Goswami, 6. Sri.Rohit Oraon, 7. Sri. Keshar Chhetri, son of B.S. Chhetri, all are resident of Devidanga Colony, Post Office Champasari, Police Station Pradhan Nagar, Dist Darjeeling, 8.Smt Sanju Chhetri, Daughter of Kumar Chhetri, wife of Sri Sajan Subba, resident of Dilaram Tea Estate under St. Mary G.P, Post Office Tung , Police Station Kurseong, Dist Darjeeling .for threatning and illegally trespassing my Land and thereafter they had stopped their illegal activities .
3. That on dated 26 th November , 2023 the above named persons broke my lock and gate and re - entered my land and started creating nuisance .
I would be grateful if your concerned authority may take an immediate action against the abovenamed accused person.
