My mother is the absolute owner of piece and parcel of land situated at Plot No. 19/356 (R.S.) corresponding to L.R. Plot No.s 281, 282 and 283 located at Thiknikata, P.S. Matigara Dist: Darjeeling. The land was registered in the name of my mother as and by way of Registered Deed of Conveyance dated 20/02/2012. On this background I place all my *bonn fides* before you and urge you to take immediate steps in order to resolve the issue and ensure that no harassment is caused to any of the concerned parties.
