That I entered into an agreement for sale with Shri Dipu Singha, Son of Late Iswar Chandra Singha, (Having Mobile Number- 8927009240) resident of Thiknikara, Opposite Naba Jubok Sangha, P.O. Sushrutanagar, P.S. Matigara, Dist- Darjeeling, Pin-734012 in the State of West Bengal, dated-25.10.2021 for purchasing a land measuring about 8 decimal or 5 kathas, recorded . in L.R. Khatian No. 651, in L.R. Plot No. 602, situated within Mouza Pelku, J.L No. 73, Touzi No. 91, Pargana Patharghata, Police Station- Matigara, Sub-division Siliguri, Addl. District Sub Registry Office Siliguri - II at Bagdogra, District- Darjeeling in the state of West Bengal, more fully described in the schedule below with a valuable consideration of Rs-12,80,000=00 and I paid Rs-2,80,000=00 as an advance or part consideration for the said land more fully described in the schedule and out of said Rs-2,80,000=00 I paid Rs- 1,80,000=00 on 25.10.2021, i.e on the date of execution of the agreement by cash and I also paid Rs-1,00,000=00 through my savings bank account Being No.35933117409, IFSC Code- SBIN0007245 of Hakim Para Branch to the account of Shri Samiran Singha @Samir Singha, (Having Mobile Number- 9083351504)Son of Shri Dipu Singha on 25.10.2021.

That prior to execution of said agreement dated- 25.10.2021 said Dipu Singha supplied all the documents relating to the below schedule land i.e L.R Khatian Deed of Gift (Danpatra) written in Bengali language Being No. I-168, dated 29.01.2007 which was executed by his mother Smt. Ateswari Singha, wife of Late Iswar Chandra Singha and other land related paper to me and prior to execution of said agreement said Dipu Singha, ,his son Shri Samiran Singha @Samir Singha and his adjacent neighbour Shri Hedlu Singha@ Gassain, Son of Late Bhunu Singha (Having Mobile Number- 7363860877) convinced in order to deceive all fraudulently and dishonestly induces me to pay the money and he also stated me that the land in question is free from all encumbrances, charges and mortgages etc and he have good title regarding the land in question more fully described in the schedule below and all of them convinced me to purchase the said land with the valuable consideration and on the basis of said Dipu Singha and his son and the neighbors convincing languages I was acted in terms of their inducement and thereby I was cheated by all. That after making payment of the aforesaid amount of Rs- 2,80,000=00 to said Dipu Singha and his sons account I on several occasion went their house and requested them to give registration of the land in my name and I also stated that I ready to pay the balance consideration amount to them but they all always avoided to give registration of the land in question more fully described in the schedule below with various plea and I also make several call to said Dipu Singha and his scn and the neighbors and on several occasion I requested to give registration of the land and take the balance consideration amount but they all never pay any heed to my words. That after elapsed of almost 2(Two) years I came to know from the local people that the land in question more fully described in the schedule below has already been sold by them with valuable consideration to the other people prior to execution of the aforesaid agreement for sale, dated 25.10.2021. That the activities of all of them and also the local peoples statement creates a doubt in my mind that whether they have really sold out the land prior to execution of agreement for sale or not and whether I have been cheated or not to clear my doubt I engaged a lawyer for find out the truth and my engaged lawyer thoroughly search and after searching he came to know that the land measuring 42 decimals recorded in L.R. Plot No. 602, J.L. No. 73, Touzi No. 91, Mouza- Pelku, L.R Khatian No. 651, Pargana- Patharghata, P.S. Matigara, Dist- Darjeeling has already been sold by virtue of 2(Two) Deed of Conveyance (Krishi Jomir Kobola Potro) written in Bengali, being no. I-02418 for the year 2010 recorded in Book No. I, CD Volume No. 11, Pages-771 to 789 and said Deed was executed by said Dipu Singha in the name of one Shri Bhupendranath Sarkar, Son of Late Radhanath Sarkar, resident of Jyotirmoy Colony, Ward No- 32, P.S-Bhaktinagar, Dist-Jalpaiguri and in the said deed 0.20 acre was sold out to the said Bhupendranath Sarkar and another Deed of Conveyance (Krishi Jomir Kobola Potro) written in Bengali, being no. I\_02234 for the year 2010, Book No. I, CD Volume No. 10, Pages- 1349 to 1367 and said Deed was also executed by the same person Dipu Singha in the name of Shri Chinmoyee Mondal, Wife of Nivas Mondal, resident of Sarkar Para, Bankim Nagar, P.O. Sevoke Road, P.S. Bhaktinagar, Dist- Jalpaiguri and in the said Deed he sold 0.22 acre land to the said Smt. Chinmoyee Mondal.

That after receiving the aforesaid certified copy I went to the house of said Dipu Singha and meet him and his son and the witness and neighbor of their house Shri Hedlu Singha, and I asked them all as to why you all have cheated me when you all have knowledge of the fact that there is no land in the name of you and when the land has already been sold out then why you all have executed the agreement for sale on 25.10.2021 but at that relevant point of time they all did not give any satisfactory answer to me.

That thereafter having no other alternative I sent legal notice, through my appointed lawyer Shri Ashim Chakraborty Being Legal Notice no. AC/LN/11/10/2023-24, dated-11.10.2023, through registered post with A/D to the above mentioned three accused persons and they duly received the notices but till this day they did not return back my money or take any initiative to give the registration of their other land, on the other hand all the accused person threaten me with dire consequences that if I lodge any
