guy. As he has mis-appropriated my money
which he had taken for my car's road tax.

We have a family group named 'NILAYAN'

on 12th November I was having a conversation with my cousin when Saonak Deb barged into the conversation and started abusing me with filthy language and threats. To the extent of giving me death threats.

He also stated that I am not my father's daughter and neither is my daughter the child of my husband. These all happened in the group. He stated that I am a woman of ~~low~~ low virtue and have relationships with all men I come across, including one 70 years driver who served me. He character assassinated me and my husband.

On 26.11.2023 I got an anonymous communication on a piece of paper, slipped through my flat door in Sachin Saurav Apartment.

On which it was written "You and your daughter will be finished off if you do not sign the paper".

In the above circumstances you are most respectfully requested to look into the matter by registering my complaint as an FIR against Saonak Deb and his men and agents.
