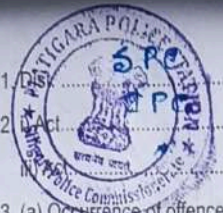


Subject: Application for Stolen Bike
